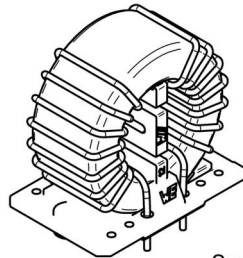
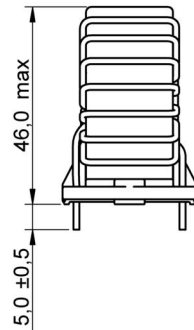
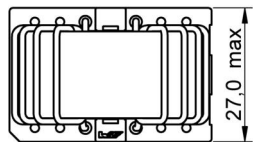

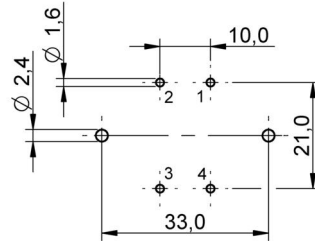

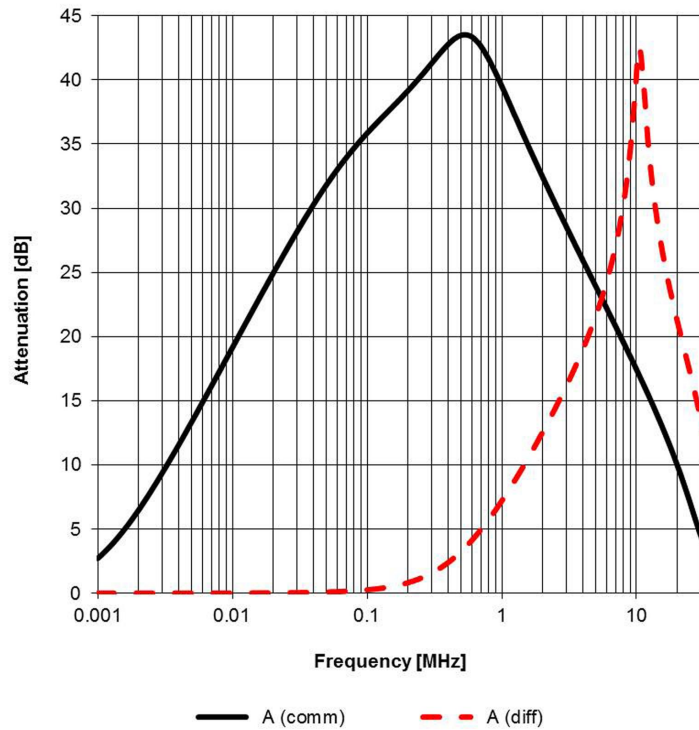



Product specific:


