# Recommended Solder Pad <sup>3)</sup>







Component Location on Pad



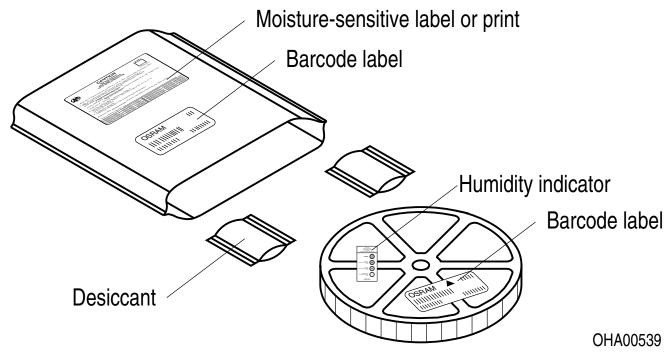




### **Barcode-Product-Label (BPL)**


