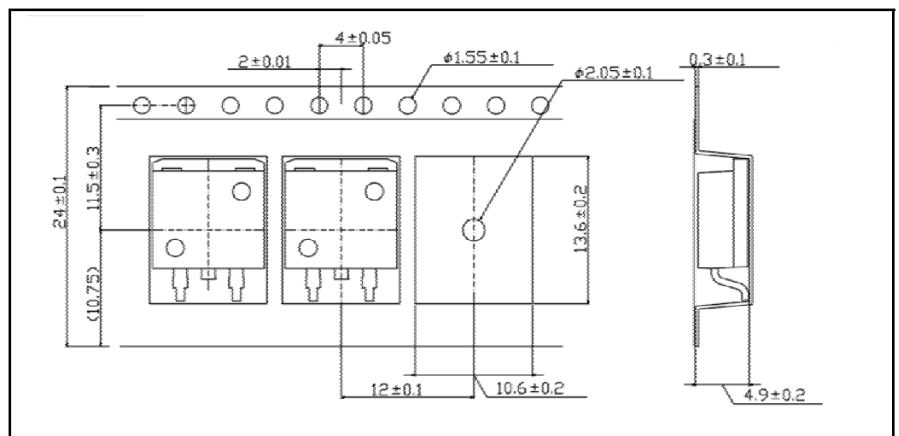
●Land size figure (Unit : mm)

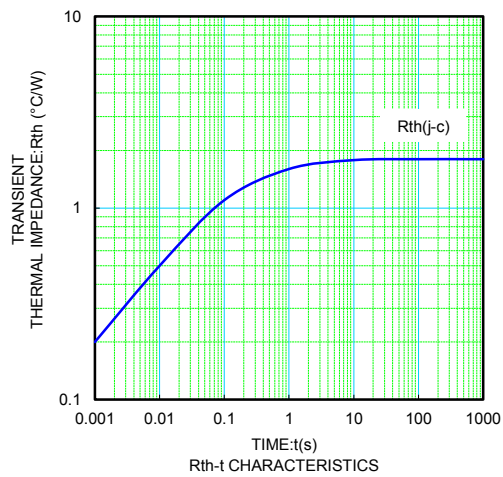
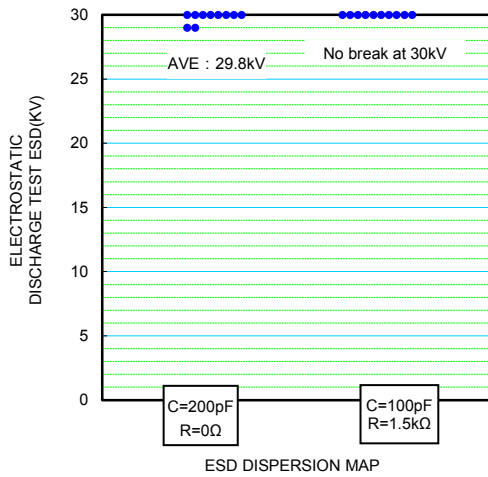
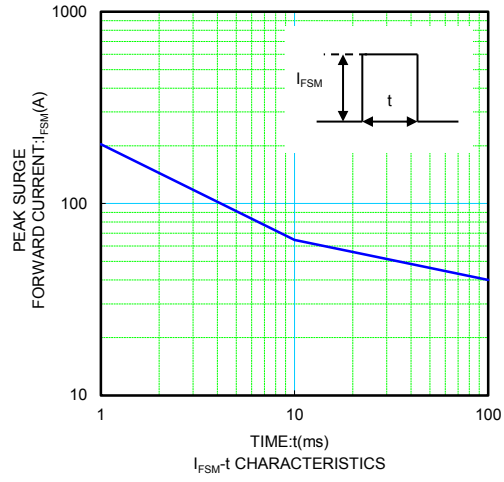
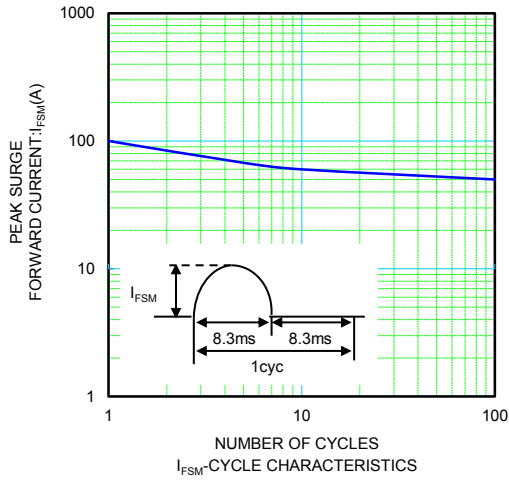


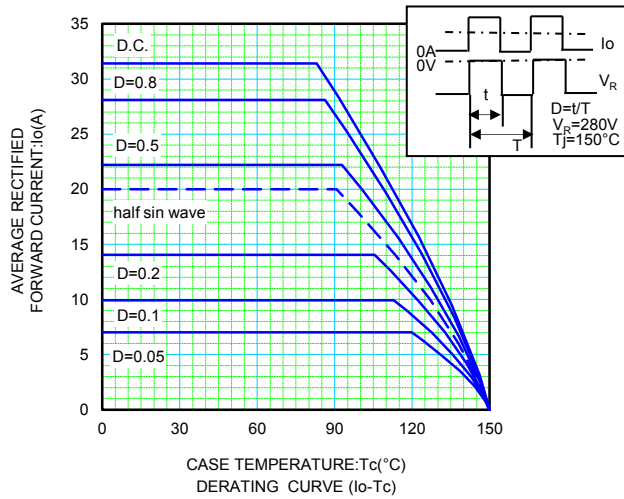
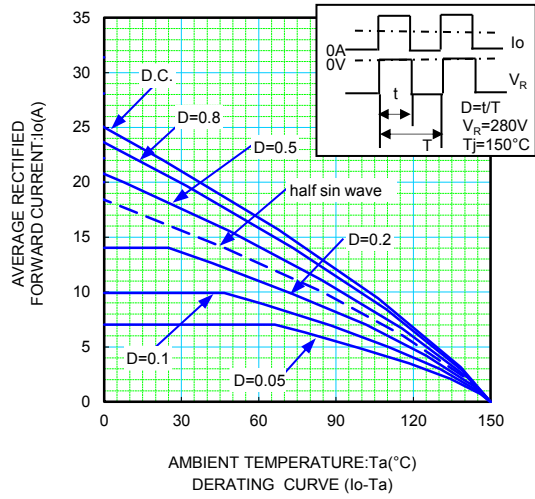
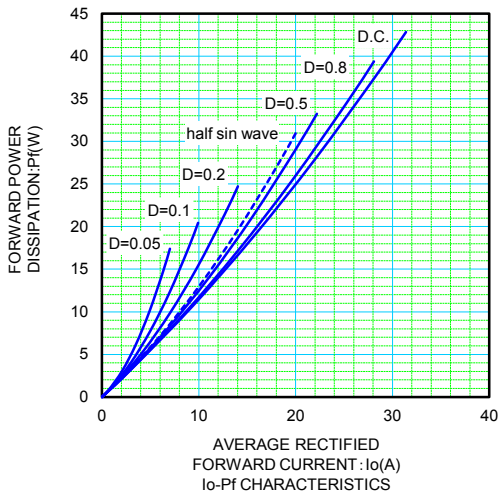


$I_{FSM}$  DISPERSION MAP
