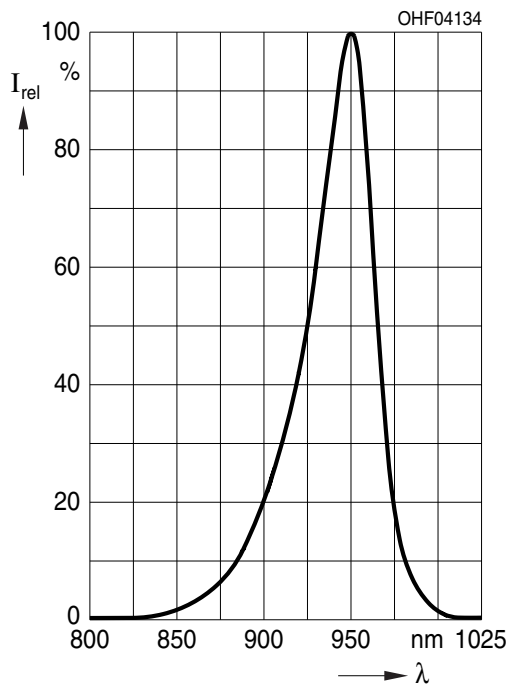

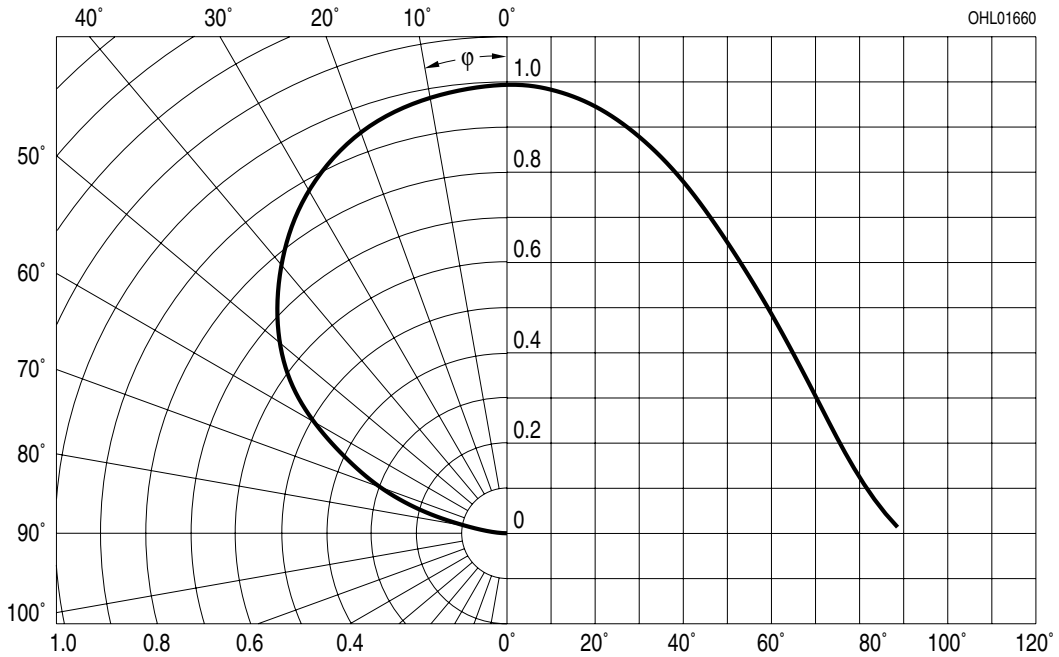
Relative Spectral Emission ^{6), 7)}

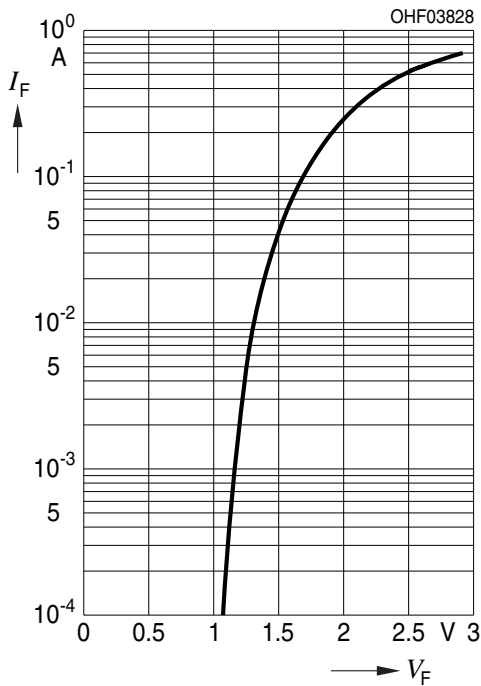
Radiation Characteristics (6), (7)

$I_{rel} = f(\varphi)$



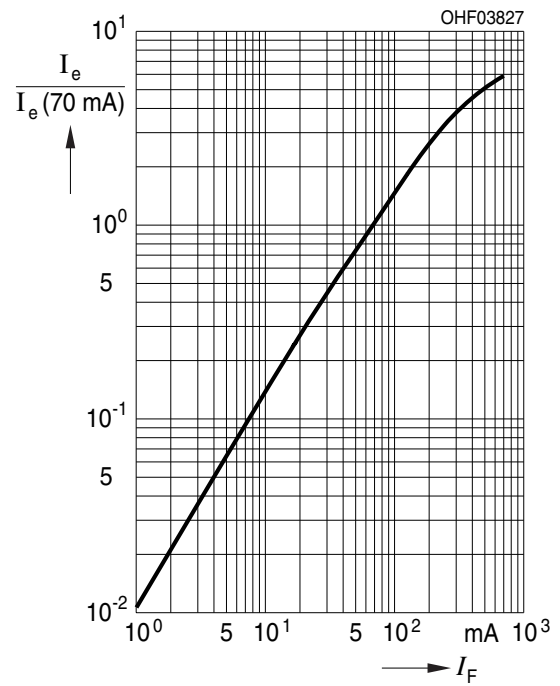
Forward current (6), (7)

$E_e/E_e(70mA) = f(I_F)$; single pulse; $t_p = 25 \mu s$



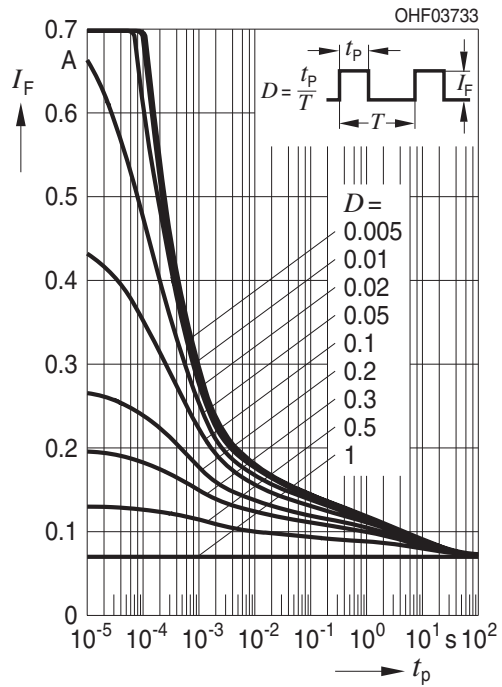
Max. Permissible Forward Current

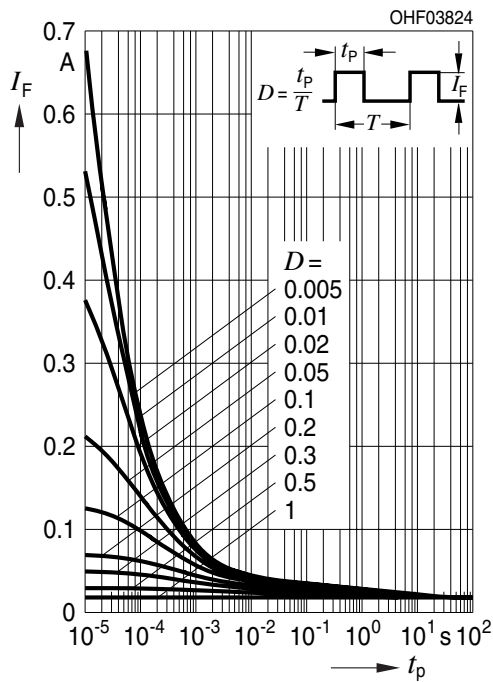
Permissible Pulse Handling Capability

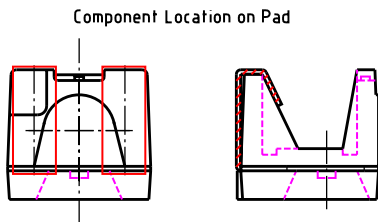
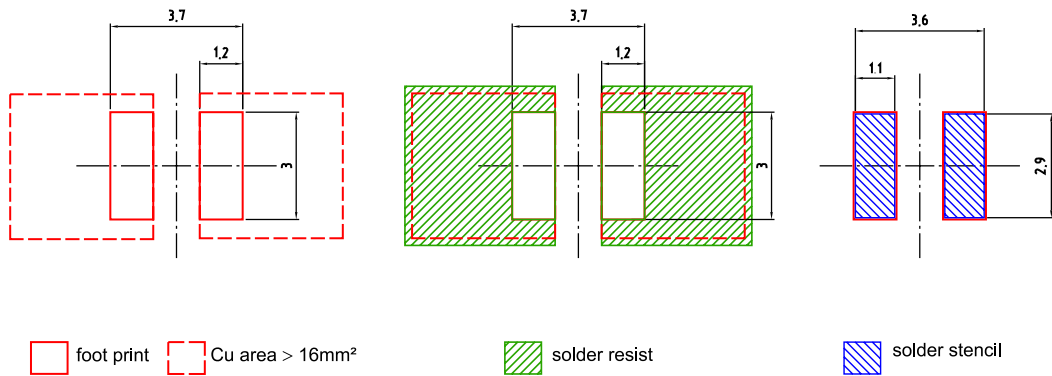


Permissible Pulse Handling Capability

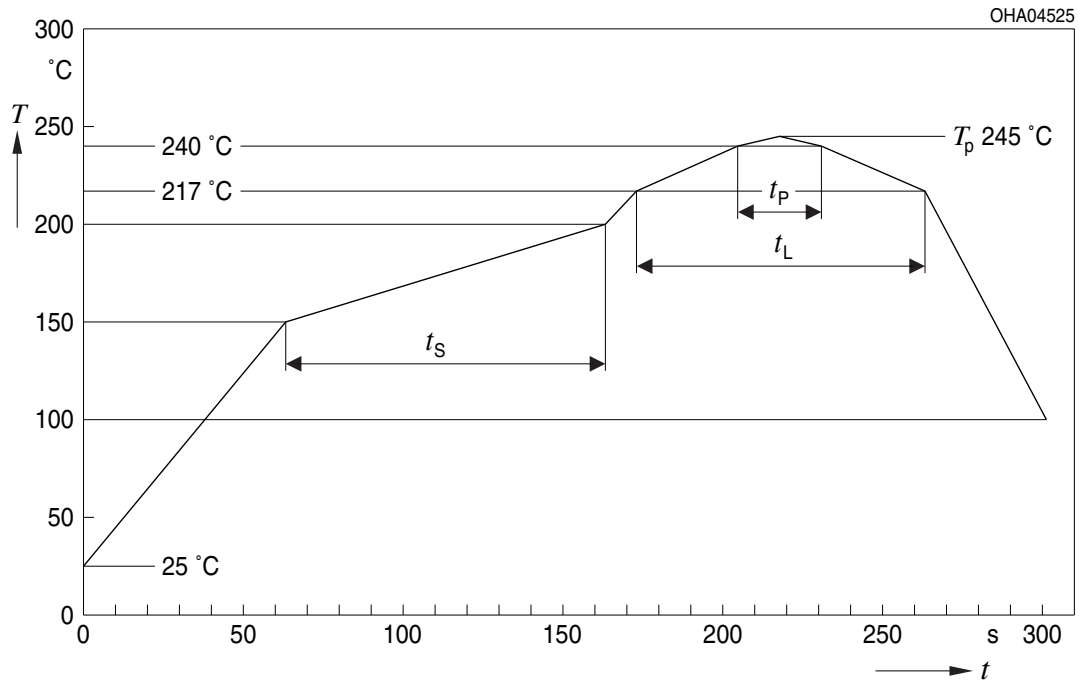
Recommended Solder Pad ⁸⁾

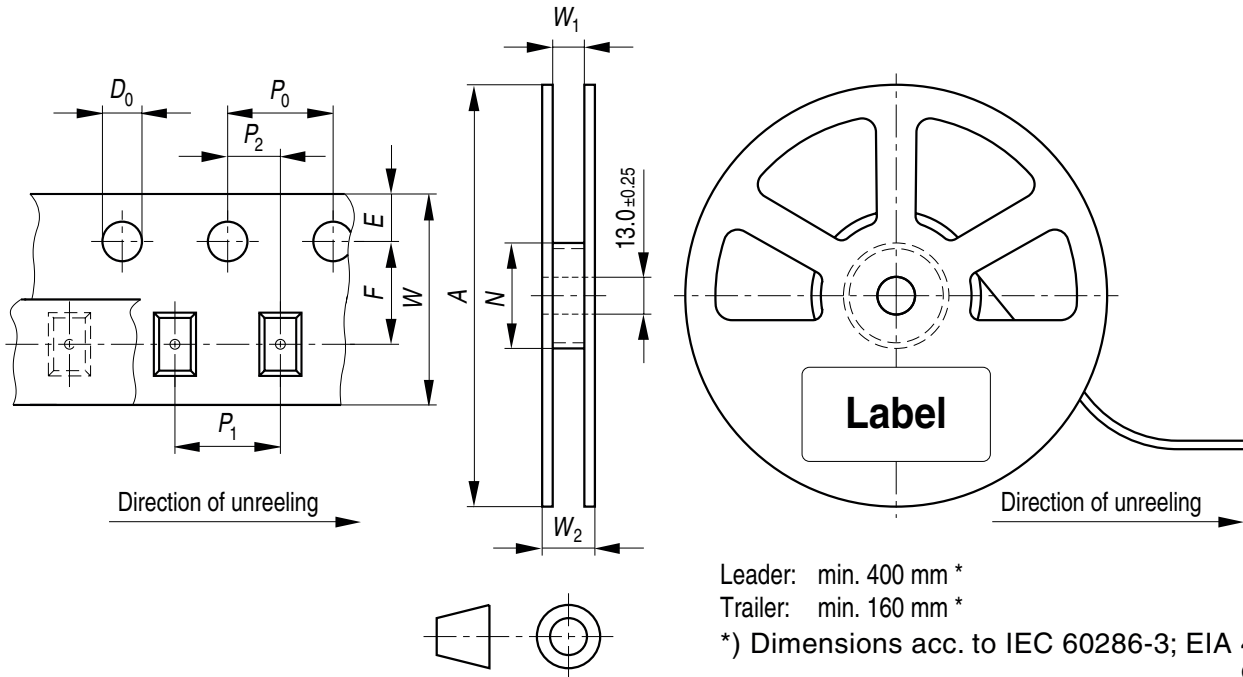

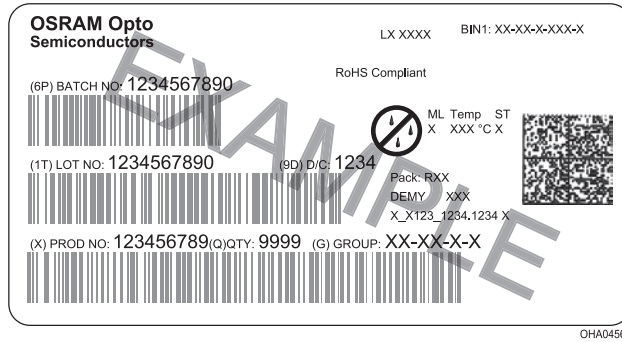

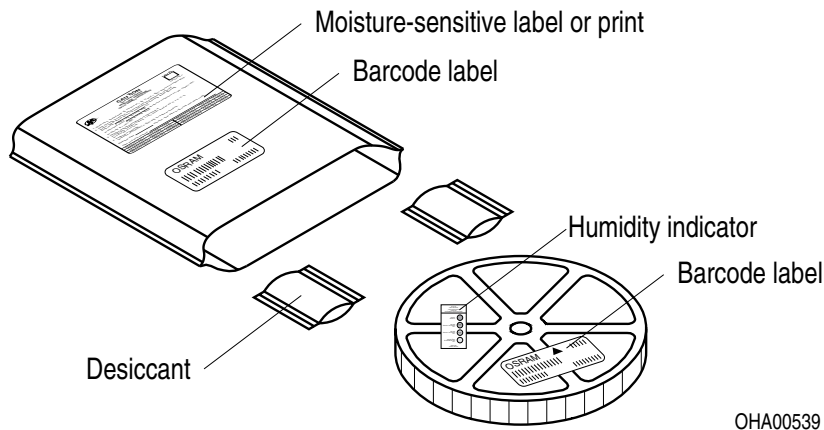

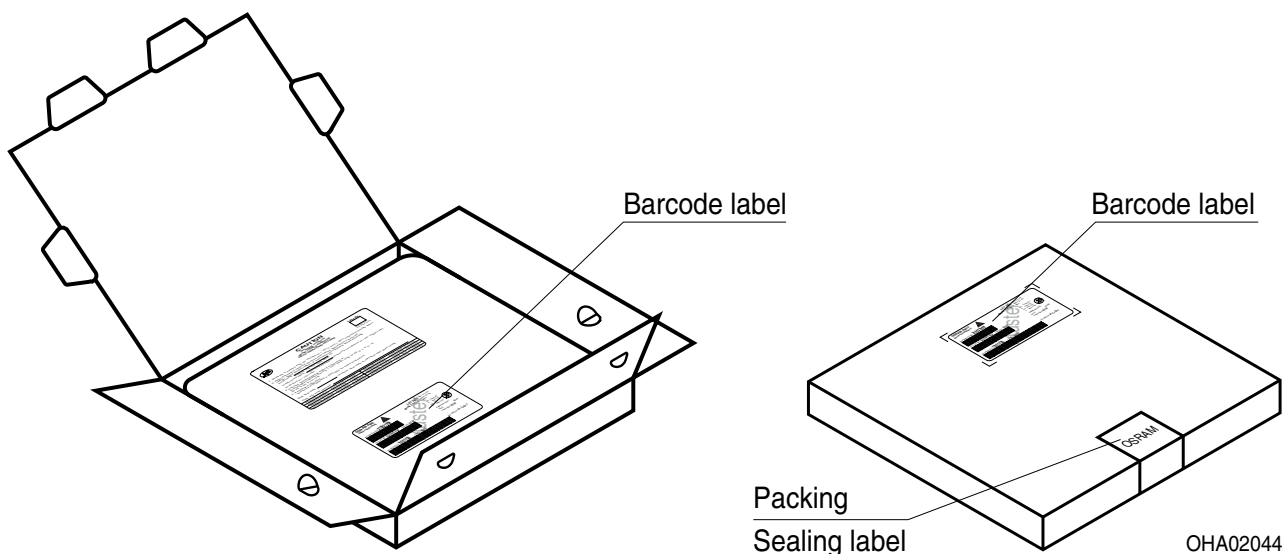


Dry Packing Process and Materials ⁸⁾

- 4) **Thermal resistance:** junction - soldering point, of the device only, mounted on an ideal heatsink (e.g. metal block)
- 5) **Thermal resistance:** junction - ambient, mounted on PC-board (FR4), padsize 16 mm² each
- 6) **Typical Values:** Due to the special conditions of the manufacturing processes of semiconductor devices, the typical data or calculated correlations of technical parameters can only reflect statistical figures.
