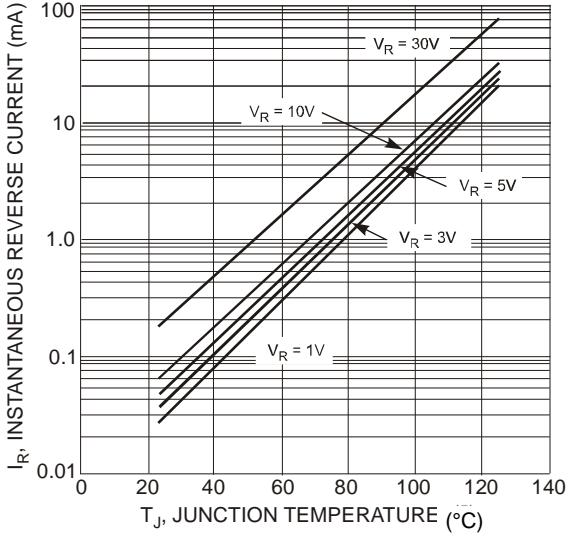


Fig. 3 Typical Pulsed Reverse Characteristics

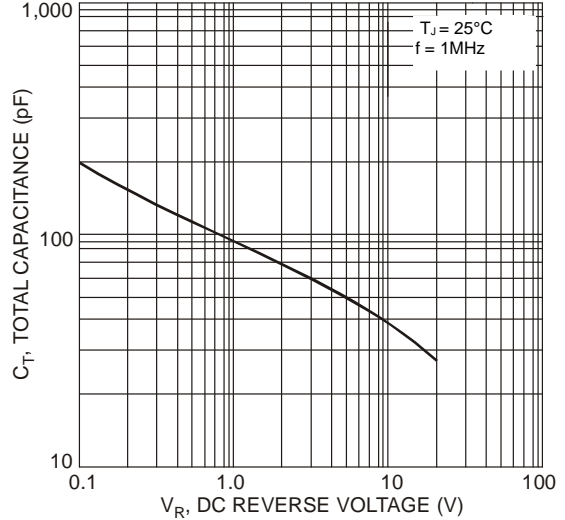


Fig. 4 Total Capacitance vs. Reverse Voltage

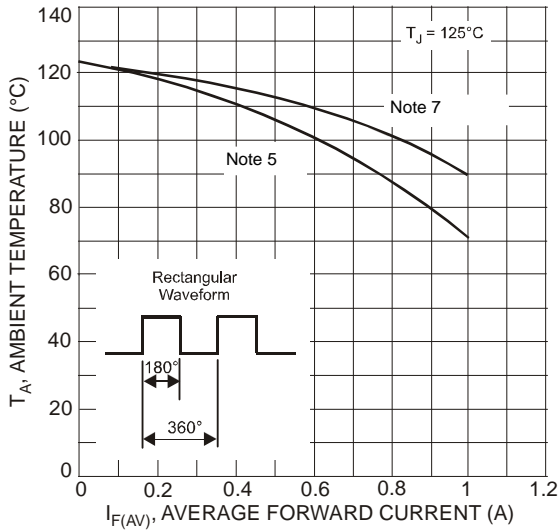


Fig. 5 Forward Current Derating Curve

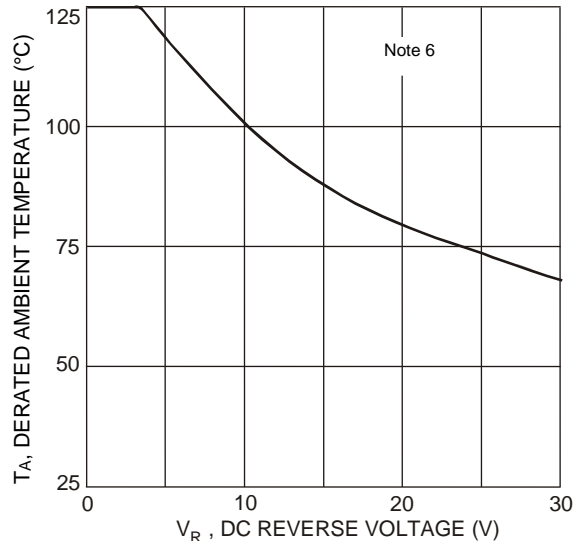


Fig. 6 Operating Temperature Derating

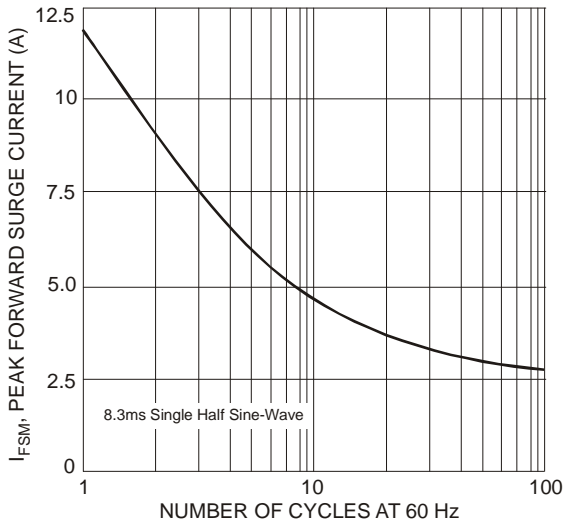


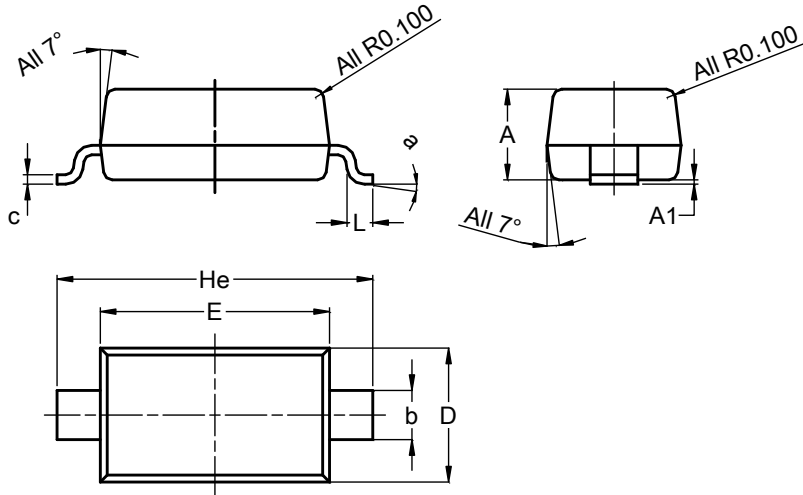
Fig. 7 Maximum Non-Repetitive Peak Forward Surge Current

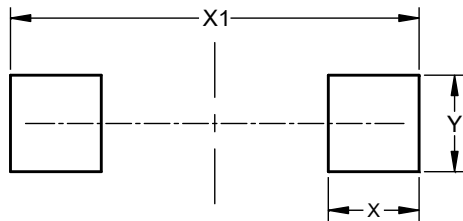
