


Relative Spectral Sensitivity ^{2), 3)}

 $S_{rel} = f(\lambda)$




Directional Characteristics ^{2), 3)}

 $S_{rel} = f(\phi)$






Dark Current ^{2), 3)}





Dimensional Drawing ⁴⁾






Recommended Solder Pad⁴⁾







Component Location on Pad



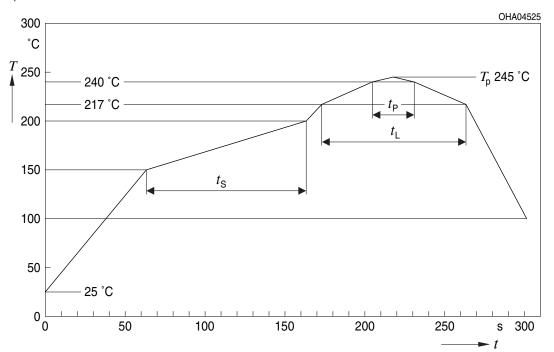






Tape and Reel ⁵⁾

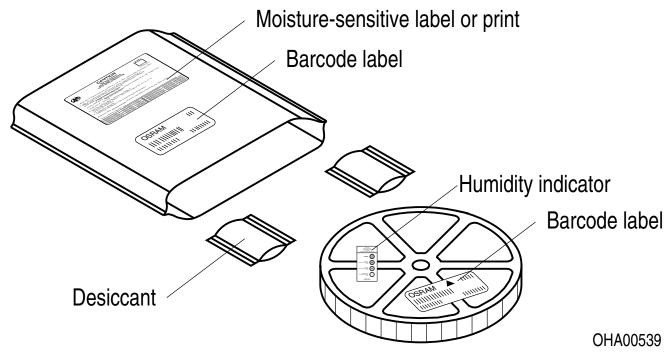




Barcode-Product-Label (BPL)
