






Fig. 8.1 Mraking RN1910FE





Fig. 8.2 Mraking RN1911FE




Fig. 9.7 RN1910FE V_{CE(sat)}-I_C


Fig. 9.8 RN1911FE V_{CE(sat)}-I_C
