





# MOUNTING

#### Normal Use

The capacitors are designed for mounting on printed-circuit boards. The capacitors packed in bandoliers are designed for mounting in printed-circuit boards by means of automatic insertion machines.

### Specific Method of Mounting to Withstand Vibration and Shock

In order to withstand vibration and shock tests, it must be ensured that the stand-off pips are in good contact with the printed-circuit board.


- $\bullet\,$  For pitches  $\leq$  15 mm the capacitors shall be mechanically fixed by the leads
- For larger pitches the capacitors shall be mounted in the same way and the body clamped

#### Space Requirements on Printed-Circuit Board

The maximum space for length ( $I_{max}$ ), width ( $w_{max}$ ) and height ( $h_{max}$ ) of film capacitors to take in account on the printed-circuit board is shown in the drawings.

• For products with pitch  $\leq$  15 mm,  $\Delta w = \Delta I = 0.3$  mm;  $\Delta h = 0.1$  mm

Eccentricity defined as in drawing. The maximum eccentricity is smaller than or equal to the lead diameter of the product concerned.

Unless otherwise specified, all electrical values apply to an ambient free air temperature of 23 °C  $\pm$  1 °C, an atmospheric pressure of 86 kPa to 106 kPa and a relative humidity of 50 %  $\pm$  2 %.






Capacitance as a function of ambient temperature (typical) for voltage 63 V







Max. AC voltage as a function of frequency




Max. AC voltage as a function of frequency








Max. AC voltage as a function of frequency



### POWER DISSIPATION AND MAXIMUM COMPONENT TEMPERATURE RISE

The power dissipation must be limited in order not to exceed the maximum allowed component temperature rise as a function of the free ambient temperature.


The power dissipation can be calculated according type detail specification "HQN-384-01/101: Technical Information Film Capacitors".

The component temperature rise ( $\Delta$ T) can be measured (see section "Measuring the Component Temperature" for more details) or calculated by  $\Delta$ T = P/G:

- $\Delta T$  = component temperature rise (°C)
- P = power dissipation of the component (mW)
- G = heat conductivity of the component (mW/°C)

### **MEASURING THE COMPONENT TEMPERATURE**

A thermocouple must be attached to the capacitor body as in:



The temperature is measured in unloaded ( $T_{amb}$ ) and maximum loaded condition ( $T_C$ ). The temperature rise is given by  $\Delta T = T_C - T_{amb}$ .

To avoid radiation or convection, the capacitor should be tested in a wind-free box.

### **APPLICATION NOTE AND LIMITING CONDITIONS**

These capacitors are not suitable for mains applications as across-the-line capacitors without additional protection, as described hereunder. These mains applications are strictly regulated in safety standards and therefore electromagnetic interference suppression capacitors conforming the standards must be used.

For capacitors connected in parallel, normally the proof voltage and possibly the rated voltage must be reduced. For information depending of the capacitance value and the number of parallel connections contact: <u>dc-film@vishay.com</u>

- To select the capacitor for a certain application, the following conditions must be checked:
- 1. The peak voltage (U<sub>P</sub>) shall not be greater than the rated DC voltage (U<sub>RDC</sub>)
- 2. The peak-to-peak voltage (U<sub>P-P</sub>) shall not be greater than  $2\sqrt{2} \times U_{BAC}$  to avoid the ionization inception level
- 3. The voltage peak slope (dU/dt) shall not exceed the rated voltage pulse slope in an RC-circuit at rated voltage and without ringing. If the pulse voltage is lower than the rated DC voltage, the rated voltage pulse slope may be multiplied by U<sub>RDC</sub> and divided by the applied voltage.

For all other pulses following equation must be fulfilled:

$$2 x \int_{0}^{1} \left(\frac{dU}{dt}\right)^{2} x dt < U_{RDC} x \left(\frac{dU}{dt}\right)_{rated}$$

T is the pulse duration.

- 4. The maximum component surface temperature rise must be lower than the limits (see graph "Max. allowed component temperature rise").
- 5. Since in circuits used at voltages over 280 V peak-to-peak the risk for an intrinsically active flammability after a capacitor breakdown (short circuit) increases, it is recommended that the power to the component is limited to 100 times the values mentioned in the table: "Heat Conductivity"
- 6. When using these capacitors as across-the-line capacitor in the input filter for mains applications or as series connected with an impedance to the mains the applicant must guarantee that the following conditions are fulfilled in any case (spikes and surge voltages from the mains included).


