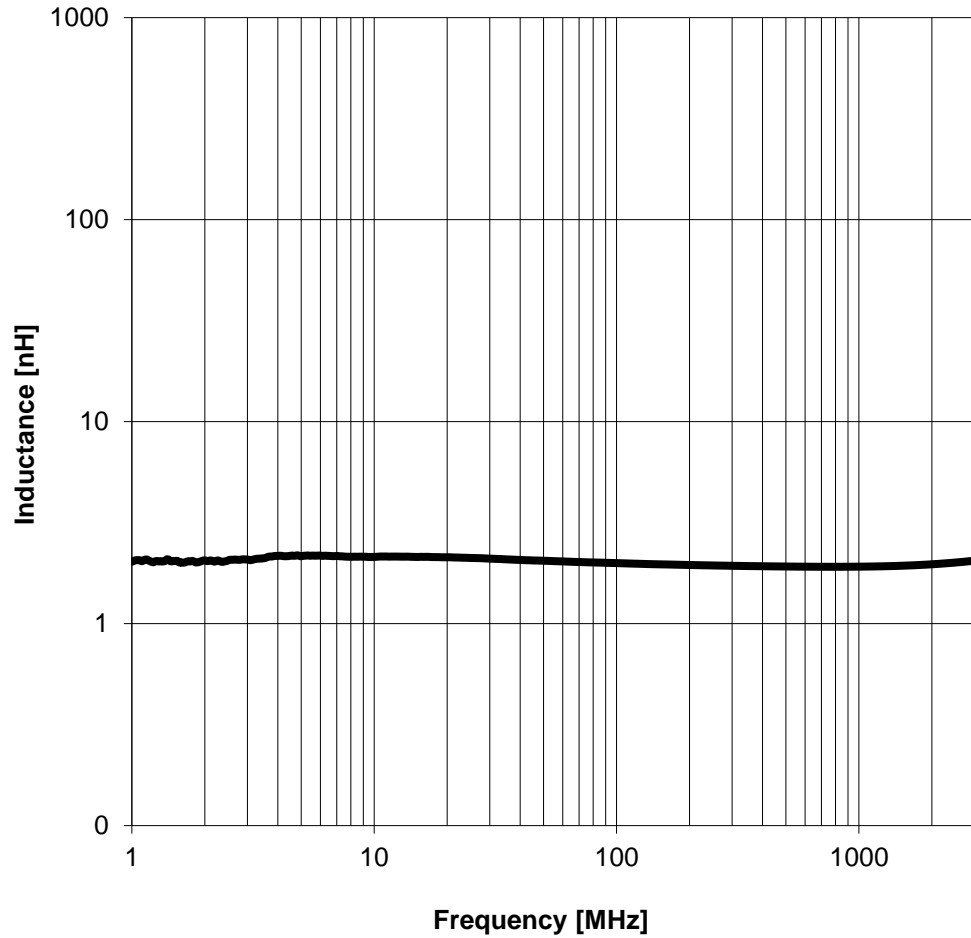

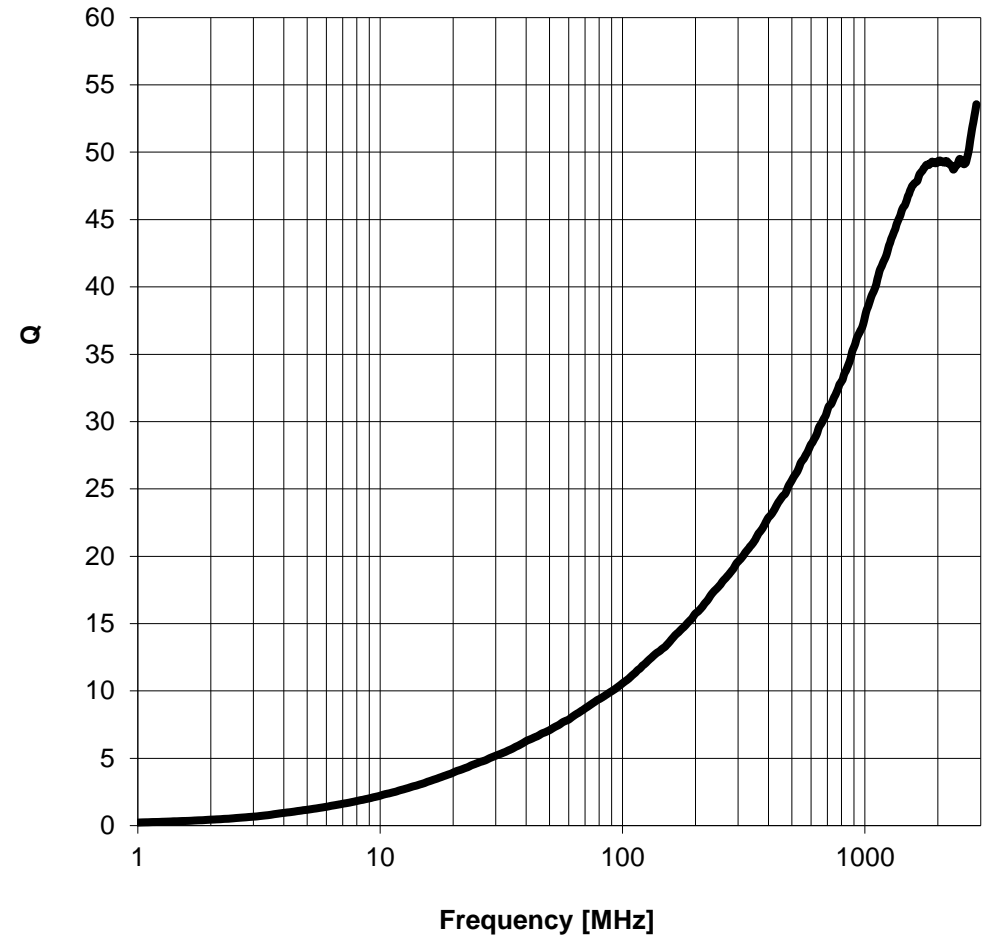

#### Soldering:

#### Potting:



## Storage Conditions:


