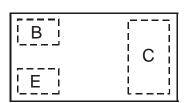

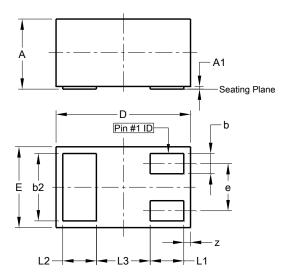






Package Outline Dimensions

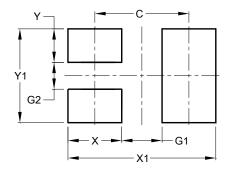
