






Fig. 2. Transient thermal impedance from junction to ambient as a function of pulse duration; typical values



Fig. 5. DC current gain as a function of collector current; typical values





Fig. 7. Collector current as a function of collectoremitter voltage; typical values









Base-emitter saturation voltage as a function of Fig. 10. Collector-emitter saturation voltage as a collector current; typical values function of collector current; typical values






