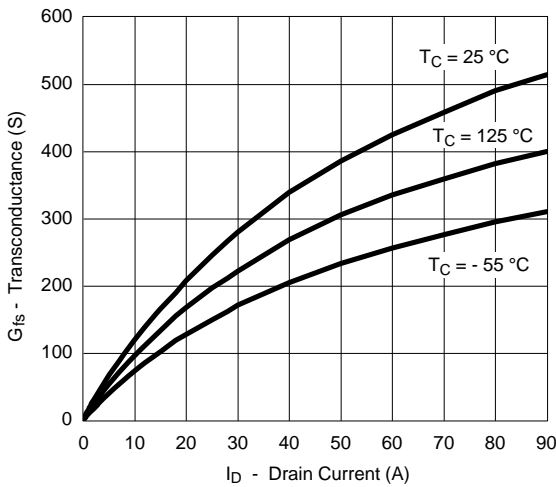

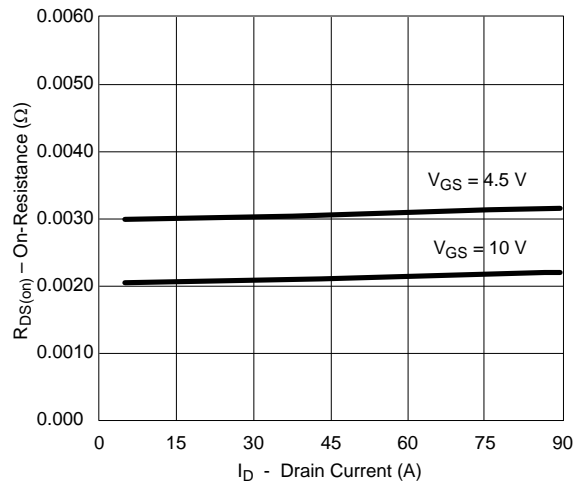

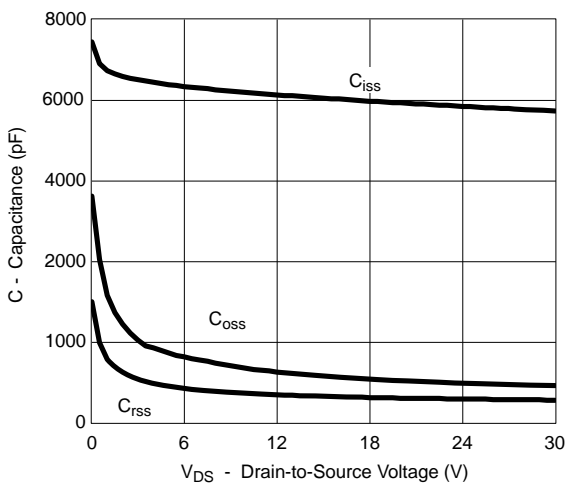

Gate Charge

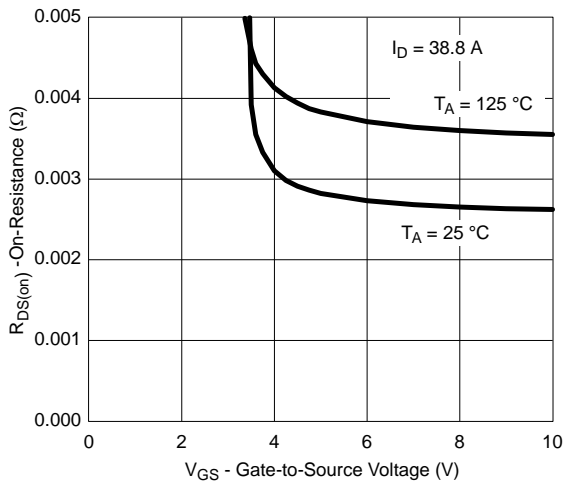

Threshold Voltage

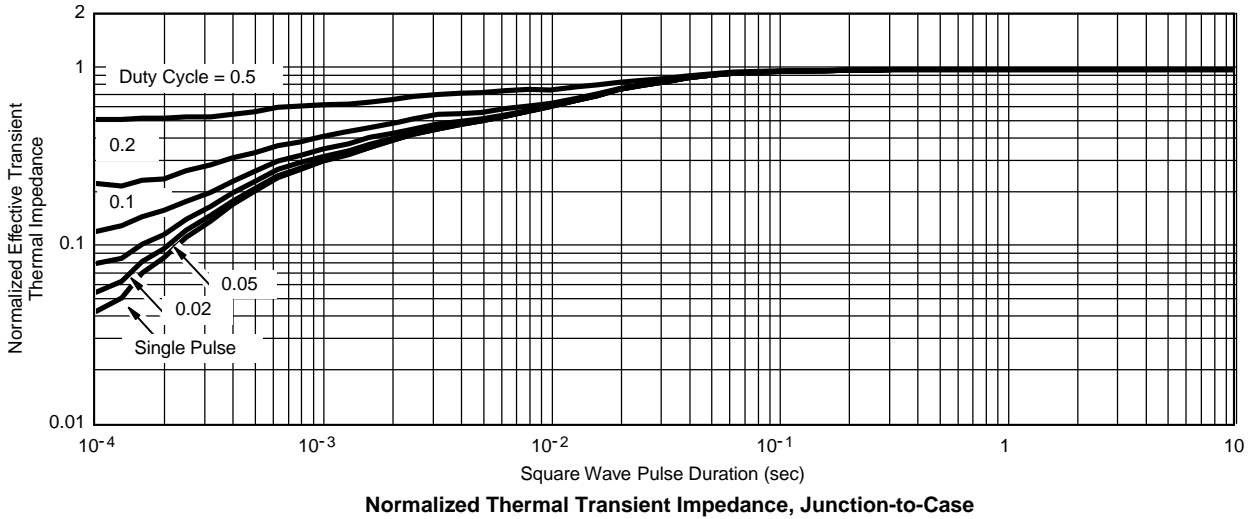

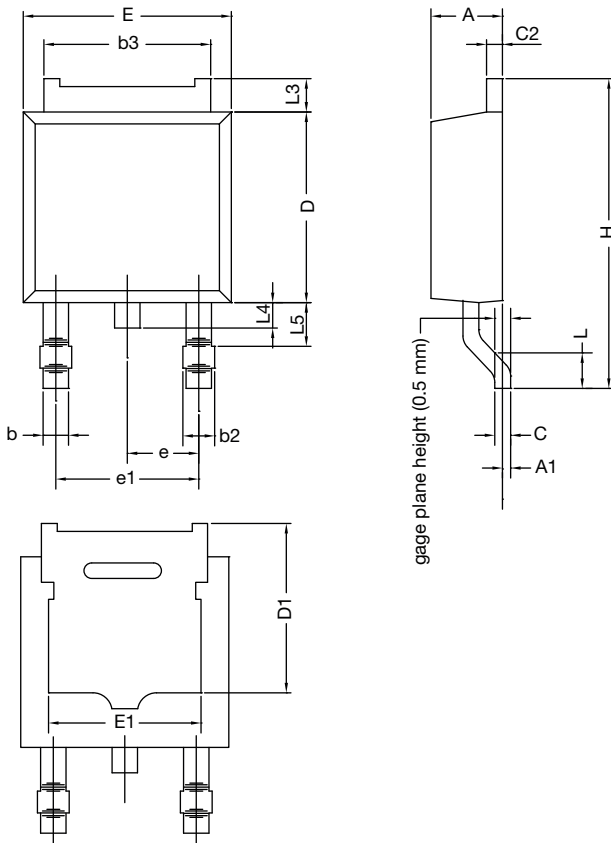
