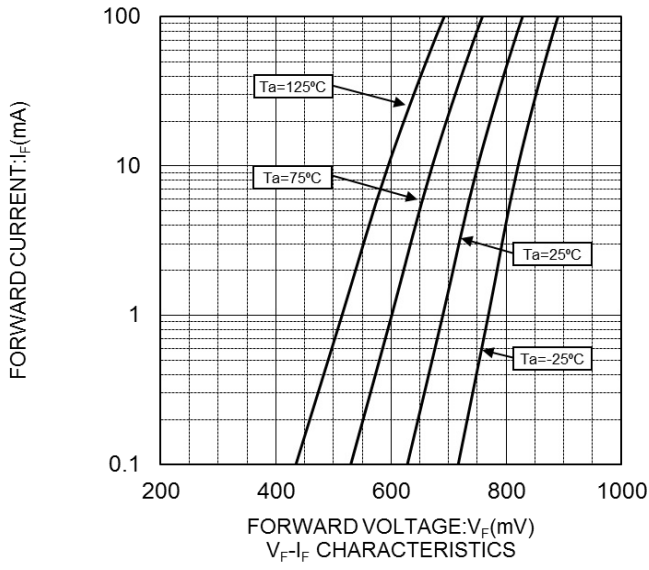
● Electrical Characteristic Curves
