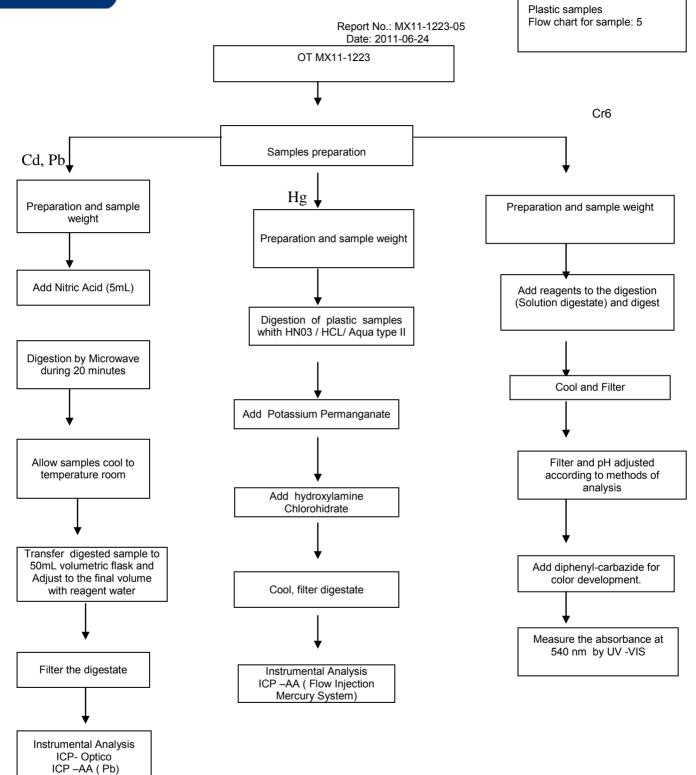

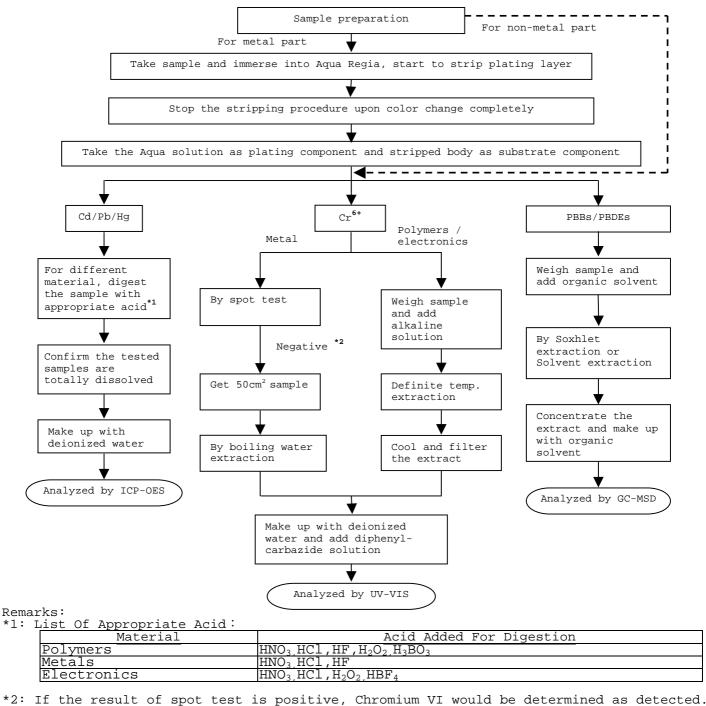

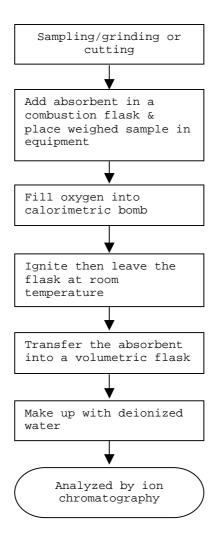

Test For Halogen Content Reference Standard: EN 14582



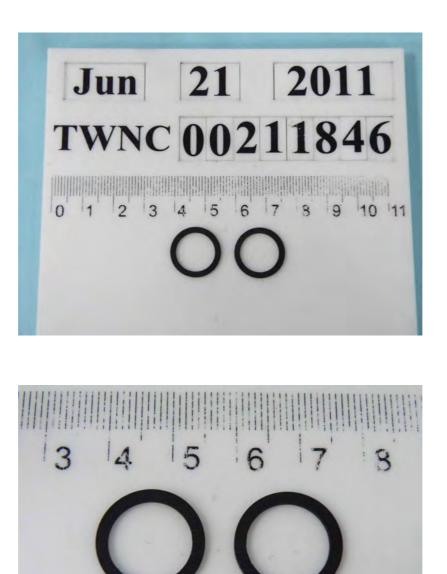

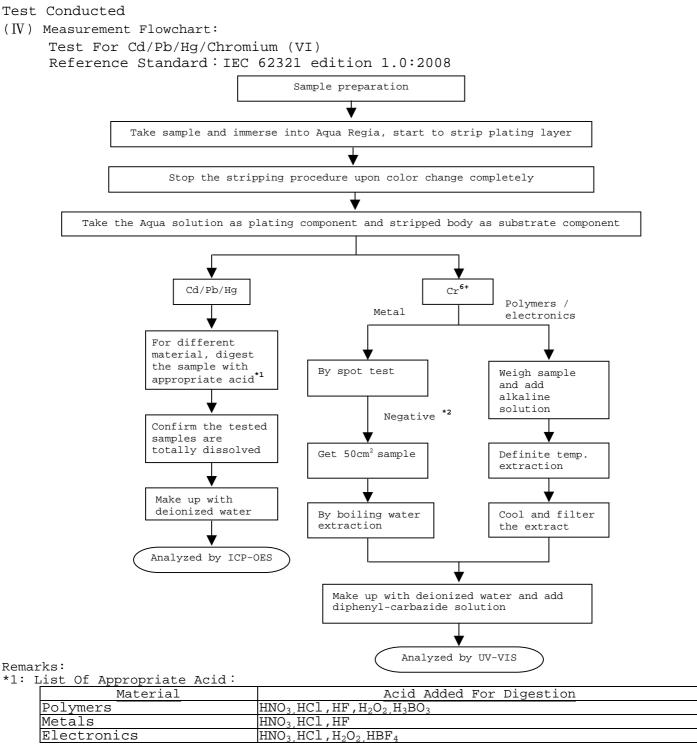

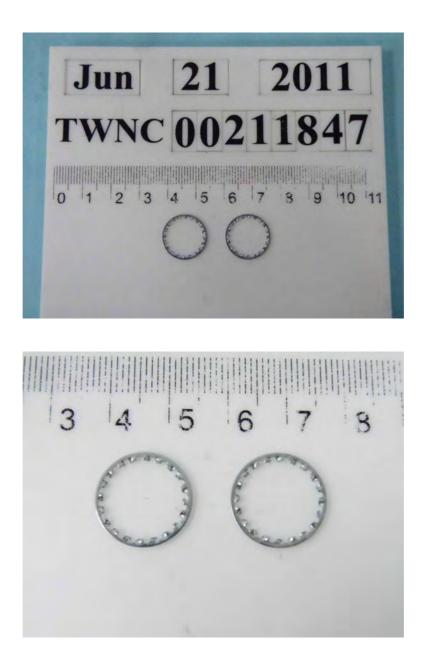
