




Figure 1. Reverse Voltage vs Reverse Current BV - 1.0 to 100  $\mu\text{A}$ 




Figure 2. Reverse Voltage vs Reverse Current  $\rm I_R$  - 10 to 100 V




Figure 3. Forward Voltage vs Forward Current  $V_{F}$  - 1 to 100  $\mu\text{A}$ 




Figure 4. Forward Voltage vs Forward Current V<sub>F</sub> - 0.1 to 10 mA




Figure 5. Forward Voltage vs Forward Current  $V_{\text{F}}$  - 10 to 800 mA




Figure 6. Forward Voltage vs Ambient Temperature  $V_{F}$  - 0.01 - 20 mA (-40 to +65 Deg C)




Figure 7. Total Capacitance




Figure 8. Reverse Recovery Time vs Reverse Recovery Current




Figure 9. Average Rectified Current  $(I_{F(AV)})$  vs Ambient Temperature  $(T_A)$ 




Figure 10. Power Derating Curve




Figure 11. 2-TERMINAL, SOD-80, JEDEC DO-213AC, MINI-MELF
