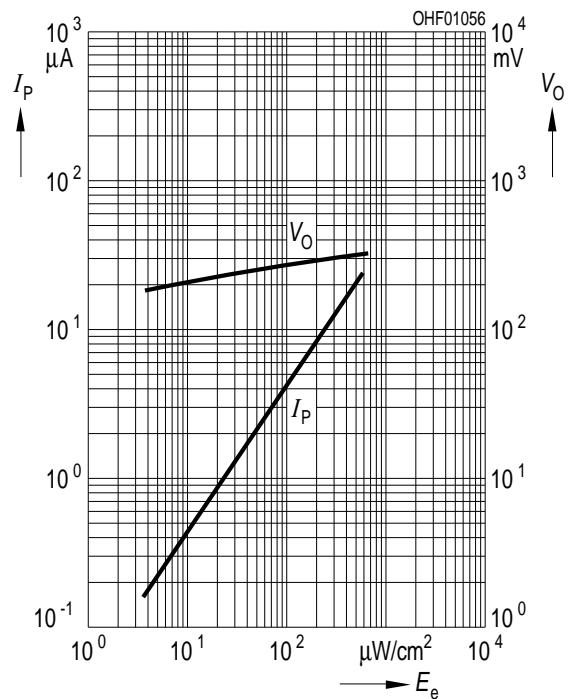

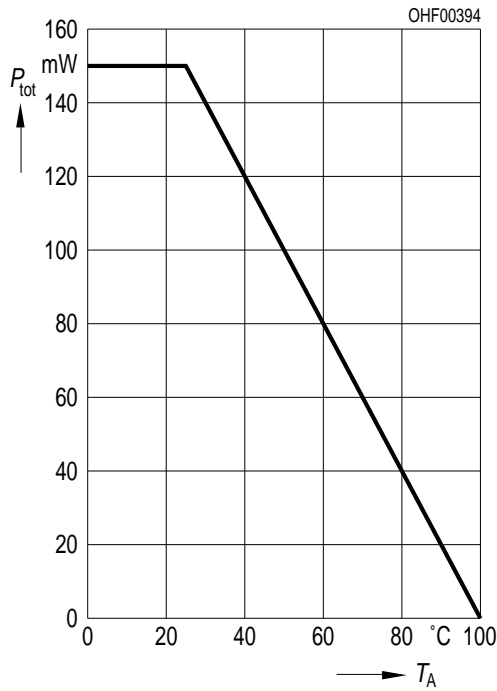
Photocurrent / Open-Circuit Voltage ^{1) page 12}

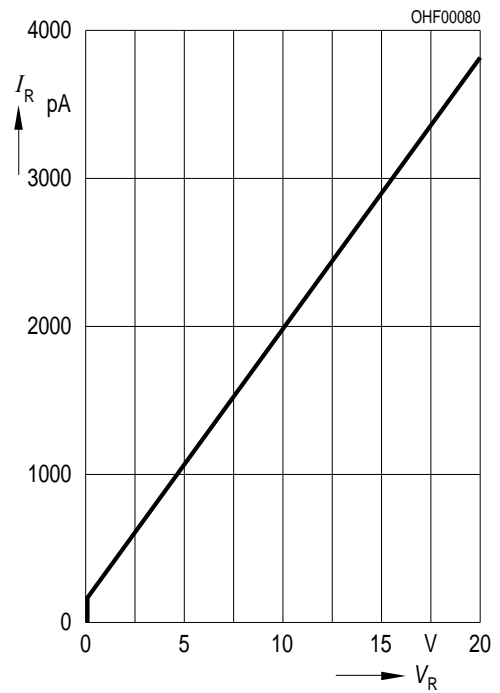
Power Consumption

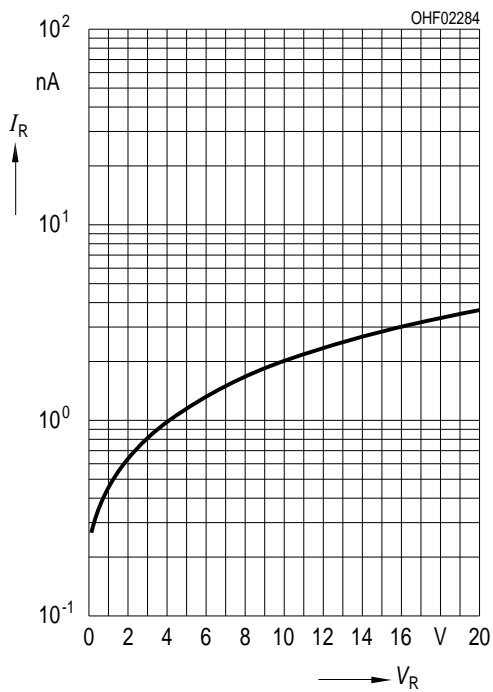

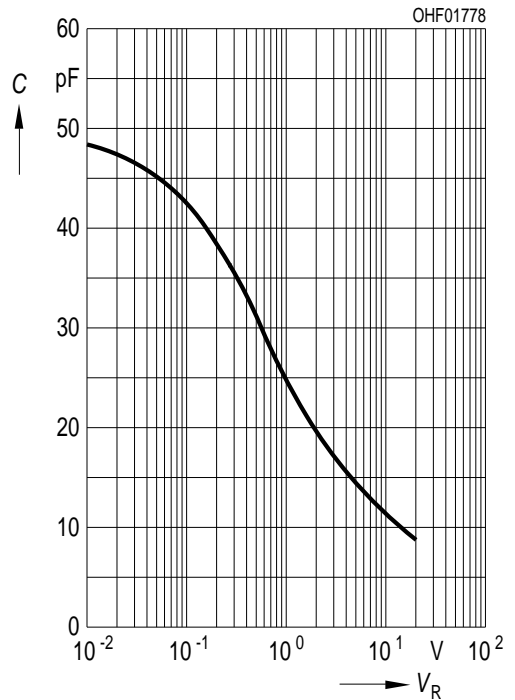

$I_R = f(V_R), E = 0$



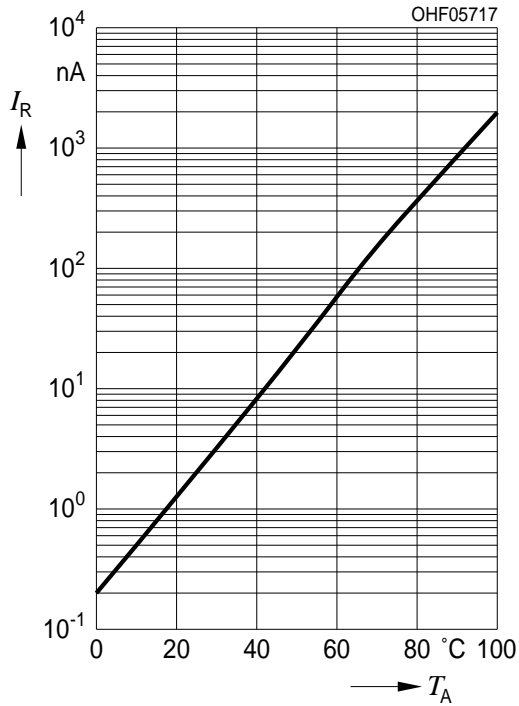
Capacitance ^{1) page 12}

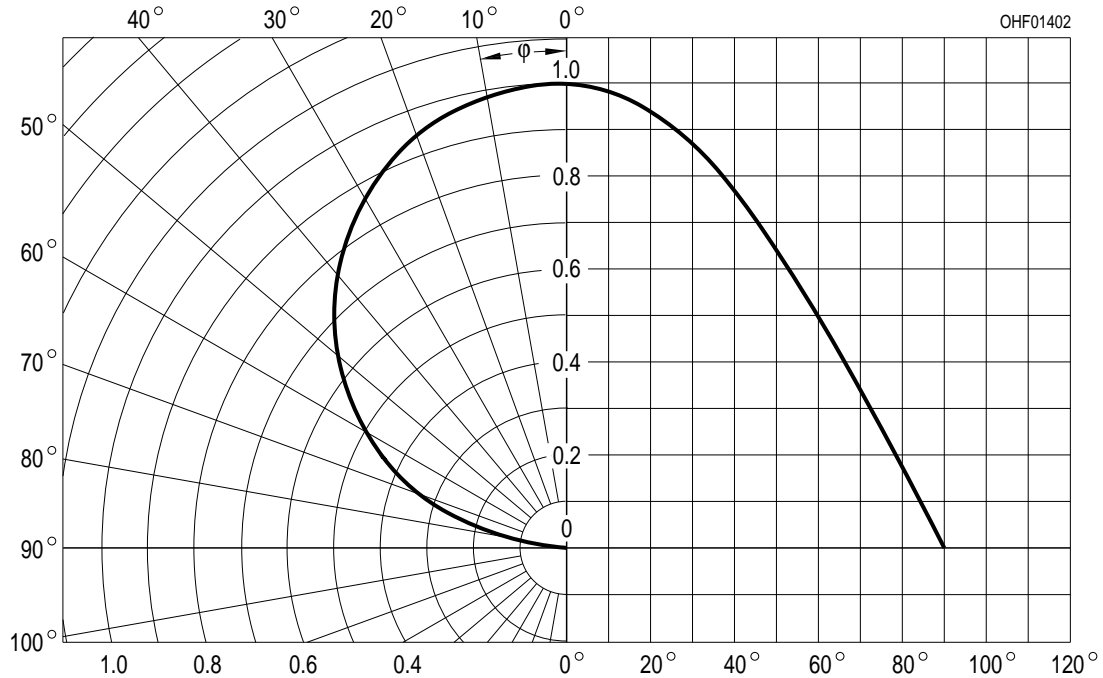

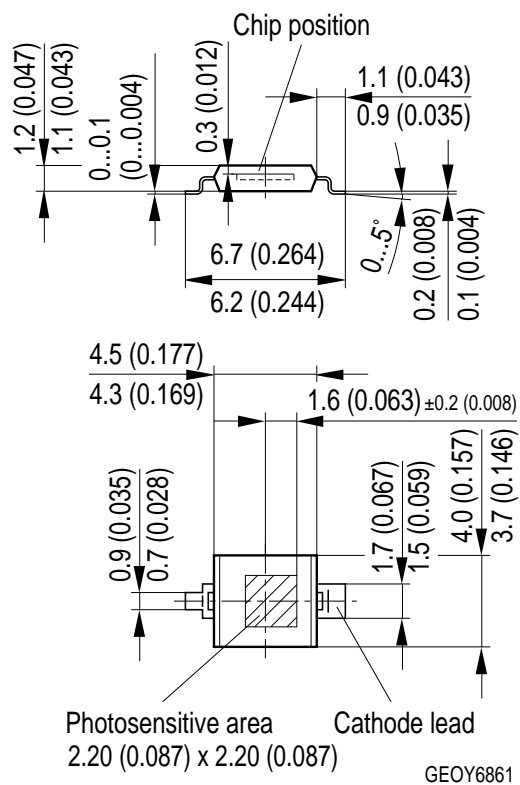


Directional Characteristics ^{1) page 12}

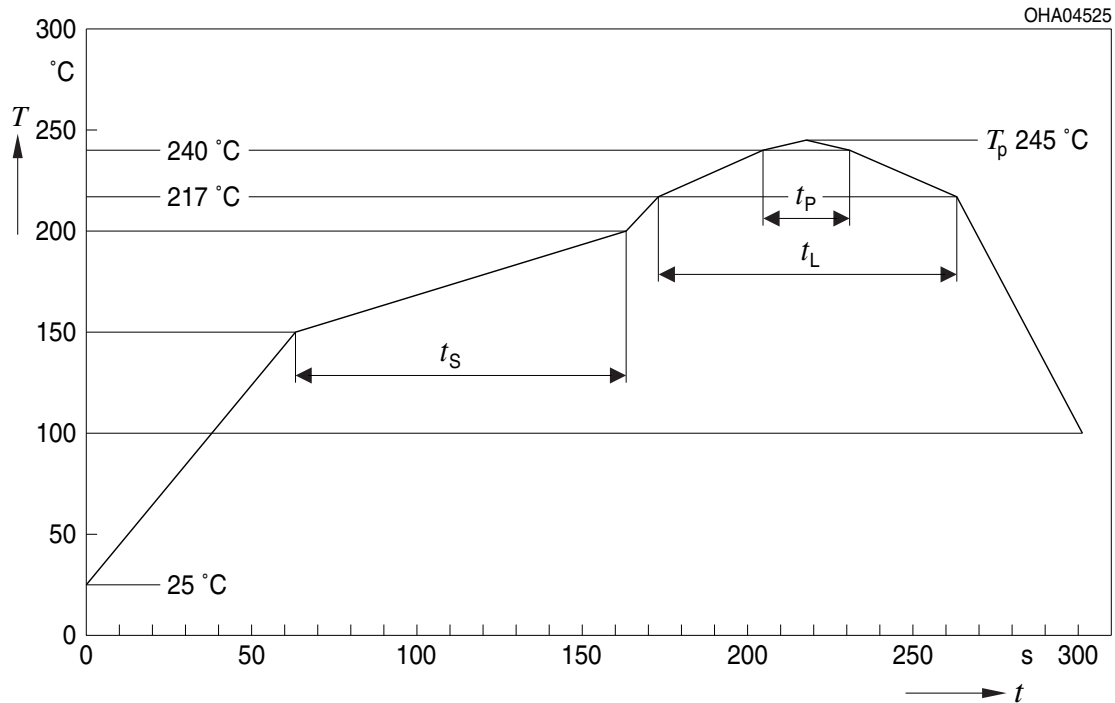

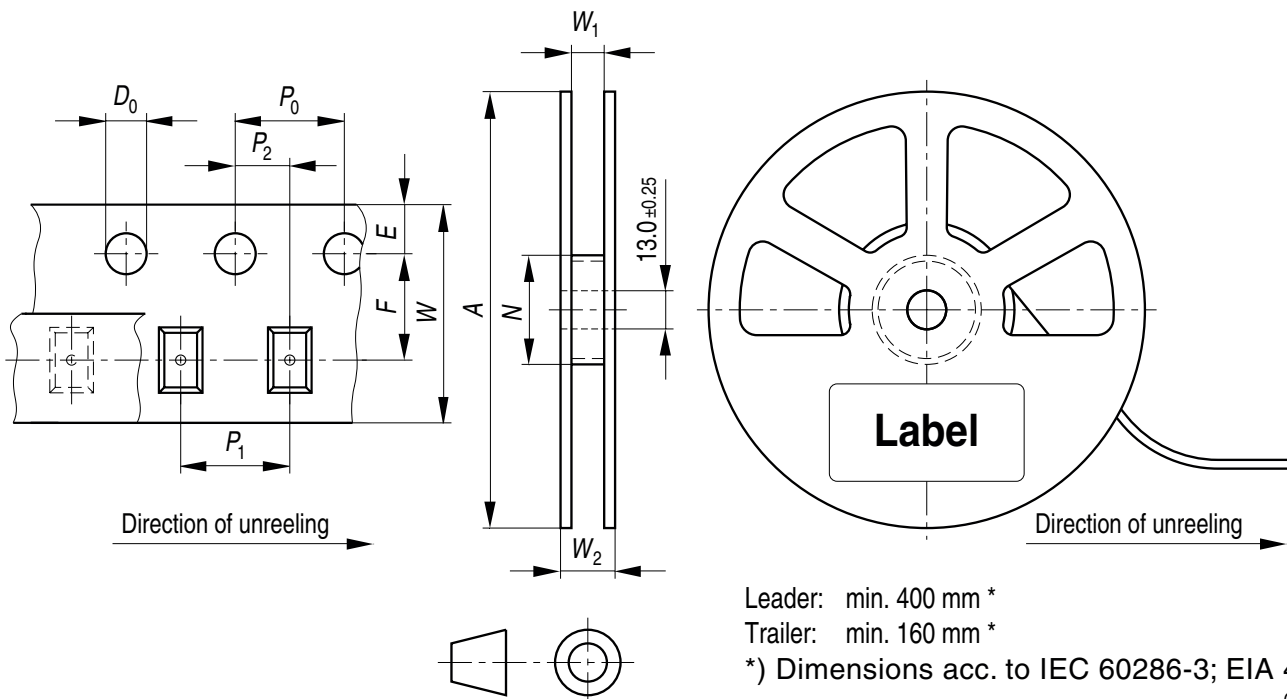

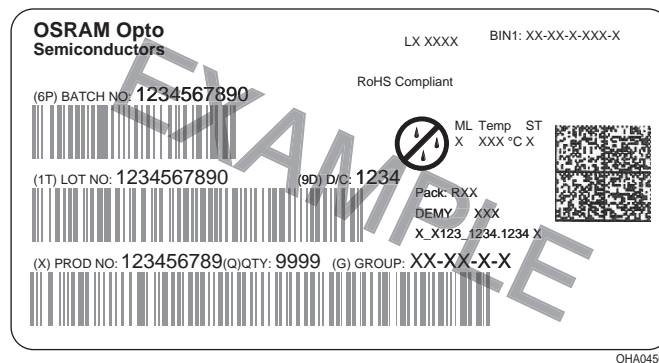
