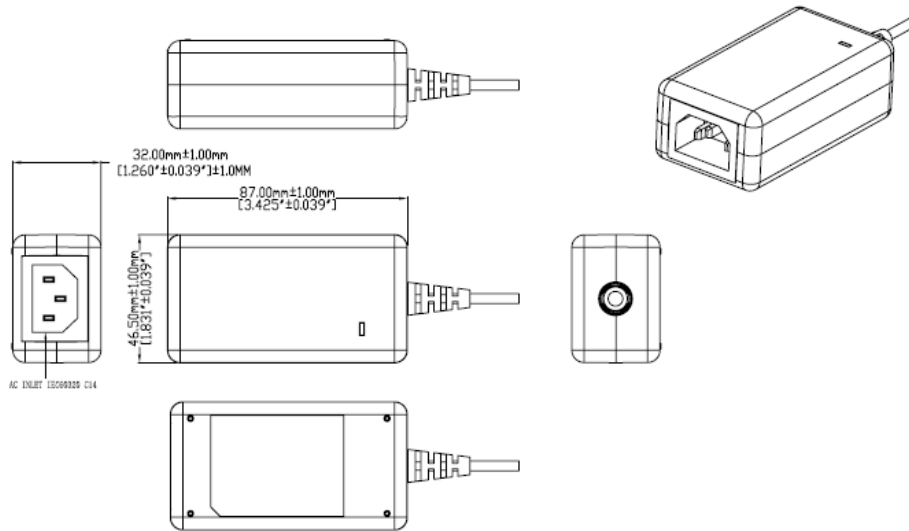

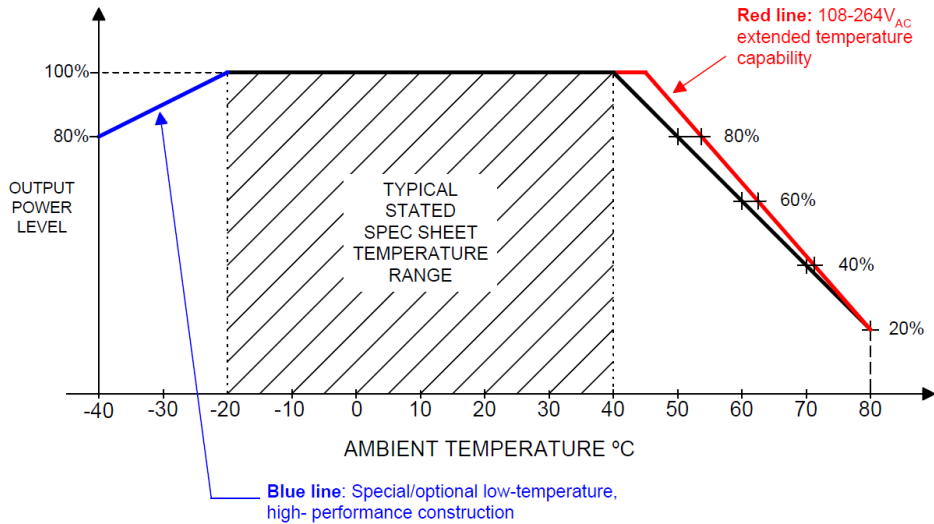

POWER SUPPLY DERATING CURVE

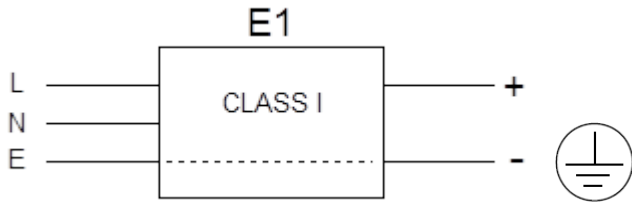
