




Fig. 5.3.1 Switching Time Test Circuit




Fig. 5.3.2 Input Waveform/Output Waveform





Fig. 6.1 Marking





Fig. 7.11 Dynamic Input Characteristics

Fig. 7.12 r_{th} - t_w






