




Fig. 1 - Recommended Operating Condition




Fig. 2 - Forward Current vs. Forward Voltage




Fig. 3 - Reverse Voltage vs. Ambient Temperature




Fig. 4 - On-State Current vs. On-State Voltage




Fig. 5 - Off-State Leakage Current vs. Ambient Temperature




Fig. 6 - Normalized Trigger Current vs. Ambient Temperature




Fig. 7 - Trigger Current vs. Turn-On Time




Fig. 8 - Normalized Holding Current vs. Ambient Temperature




Fig. 9 - Trigger Current vs. Delay Time




Fig. 10 - Trigger Current vs. Trigger Pulse Width




Fig. 11 - Trigger Current vs. Load Voltage





Fig. 12 - Tape and Reel Shipping Medium, 2000 units per reel



SOLDER PROFILE




Fig. 15 - Lead (Pb)-free Reflow Solder Profile according to J-STD-020
