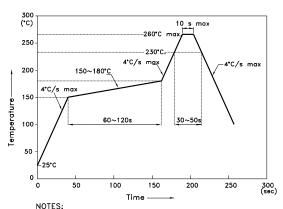

Reflow Soldering Profile For Lead-free SMT Process.




- NOTES:

 3.Number of reflow process shall be 2 times or less.


Recommended Soldering Pattern (Units: mm; Tolerance: ± 0.1)




Tape Dimensions

Reel Dimension








