










# Fig.5 Collector-Emitter Saturation Voltage vs. Collector Current (I)






# Fig.7 Base-Emitter Saturation Voltage vs. Collector Current






Fig.9 Collector Output Capacitance vs. Collector-Base Voltage Fig.10 Safe Operating Area


Fig.11 Safe Operating Area

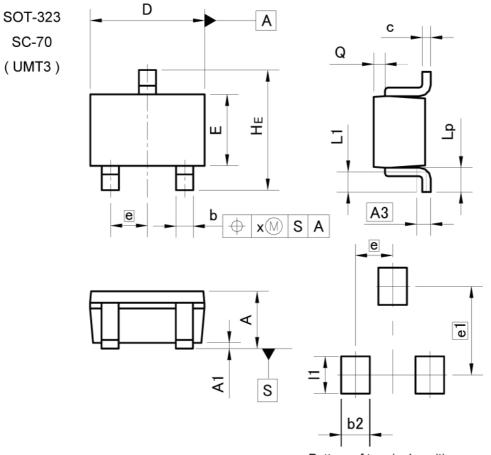
