# 1. General description

The 74LVC1G32 is a single 2-input OR gate. Inputs can be driven from either 3.3 V or 5 V devices. This feature allows the use of these devices as translators in mixed 3.3 V and 5 V environments. Schmitt-trigger action at all inputs makes the circuit tolerant of slower input rise and fall times. This device is fully specified for partial power down applications using  $I_{OFF}$ . The  $I_{OFF}$  circuitry disables the output, preventing the potentially damaging backflow current through the device when it is powered down.







#### 11.1. Waveforms and test circuit










Fig. 11. Package outline SOT753 (SC-74A)




Fig. 12. Package outline SOT886 (XSON6)




Fig. 13. Package outline SOT1115 (XSON6)




Fig. 14. Package outline SOT1202 (XSON6)

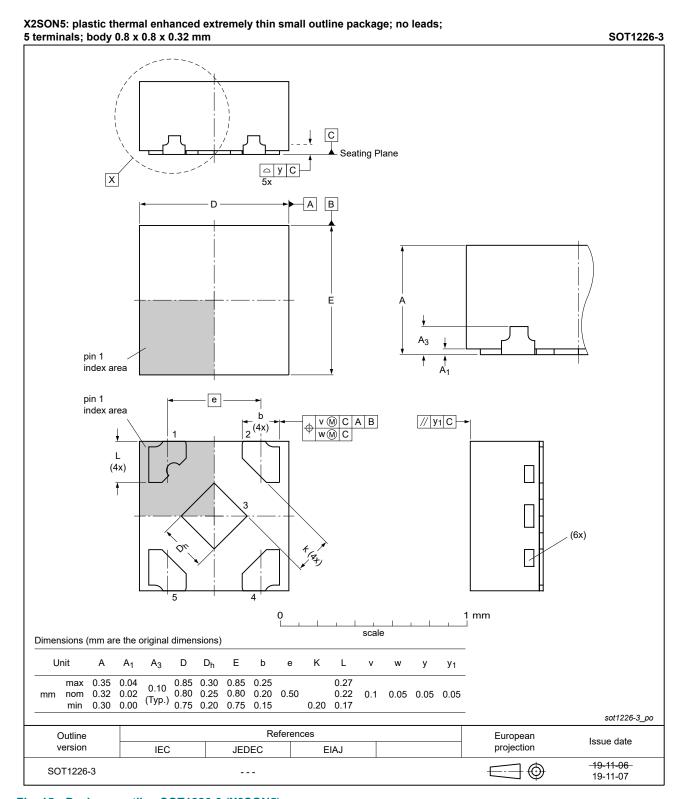


Fig. 15. Package outline SOT1226-3 (X2SON5)
