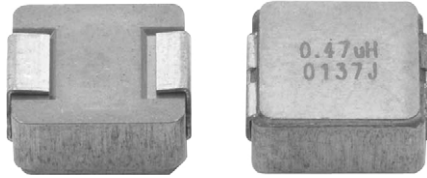

Notes
