




Figure 1. Minimum Land Pattern of 2 oz Copper




Figure 3. Forward Current Derating Curve




Figure 5. Typical Reverse Characteristic




Figure 4. Typical Junction Capacitance





Figure 6. Typical Reverse Characteristic
