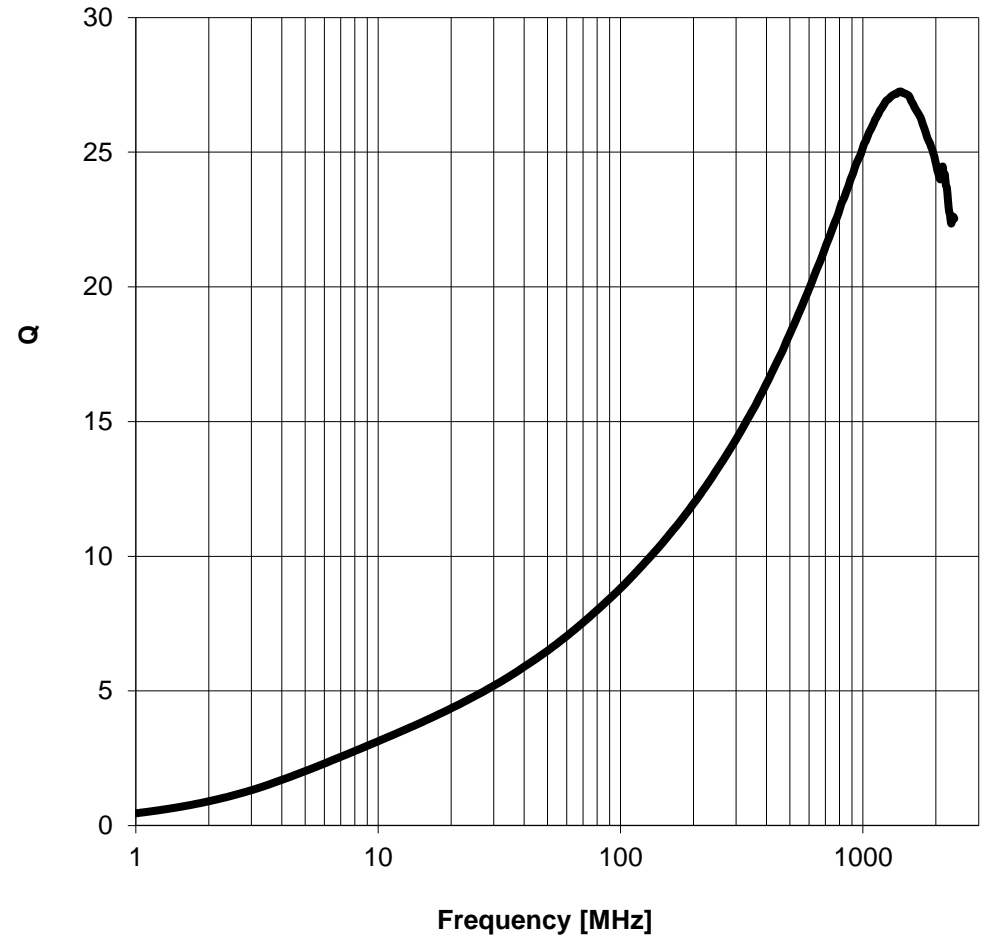




## Storage Conditions:


