## **Typical Inductance vs. Frequency Characteristics:**




## **Q-Factor vs. Frequency:**









#### Soldering:

Washing agents used during the production to clean the customer application might damage or change the characteristics of the wire

#### Potting:

manual inspection after potting to avoid these effects.


### **Storage Conditions:**
