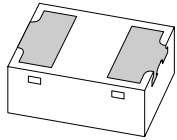



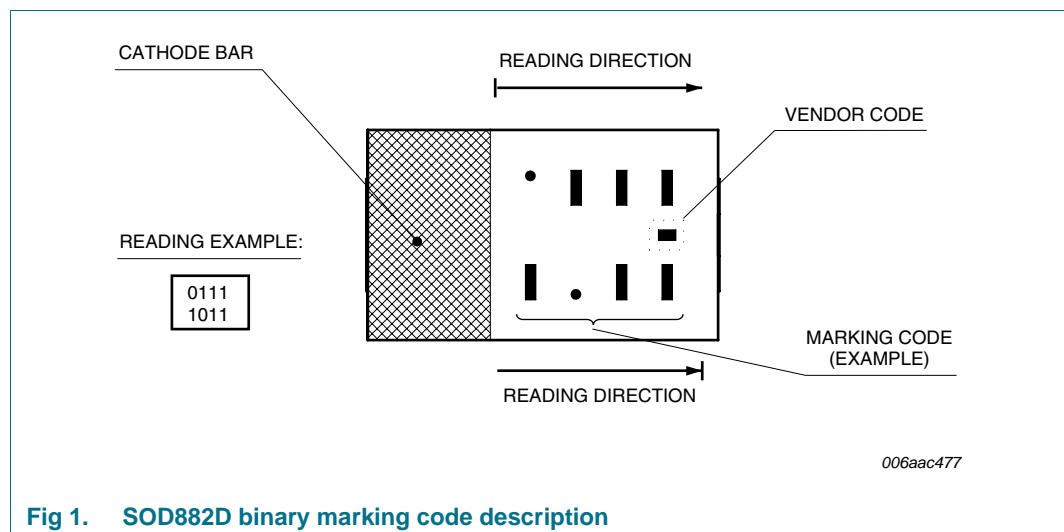


Fig 1. SOD882D binary marking code description

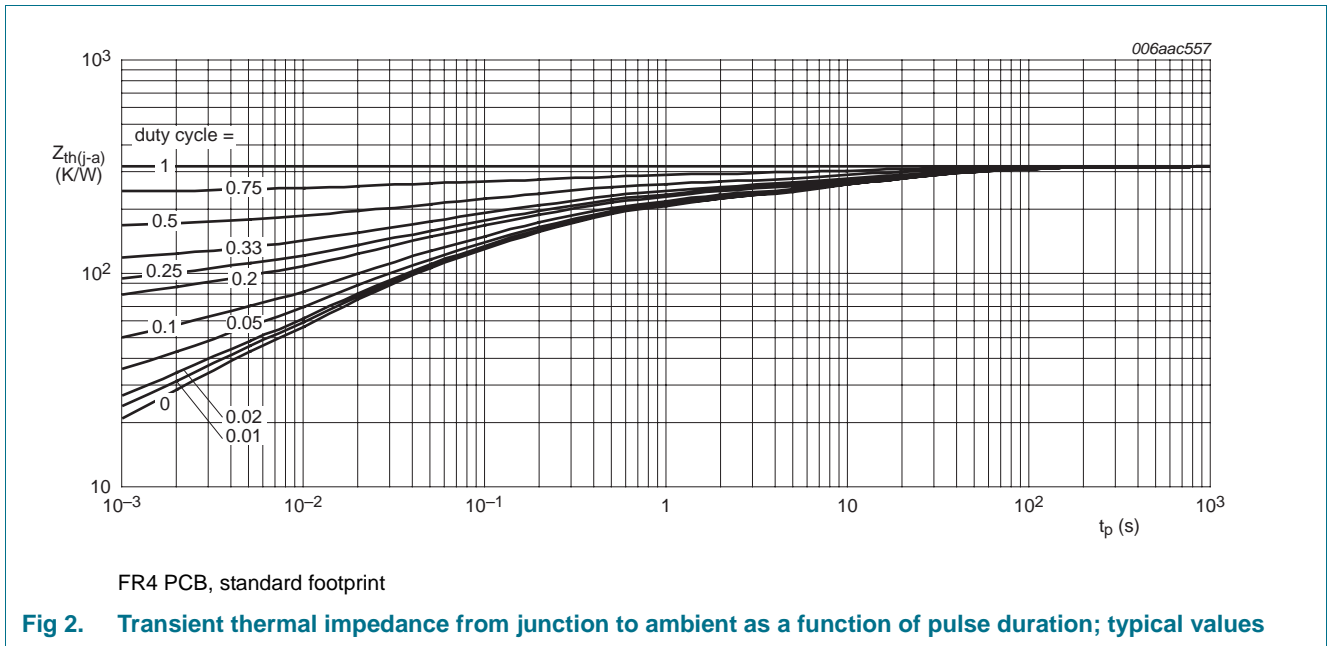

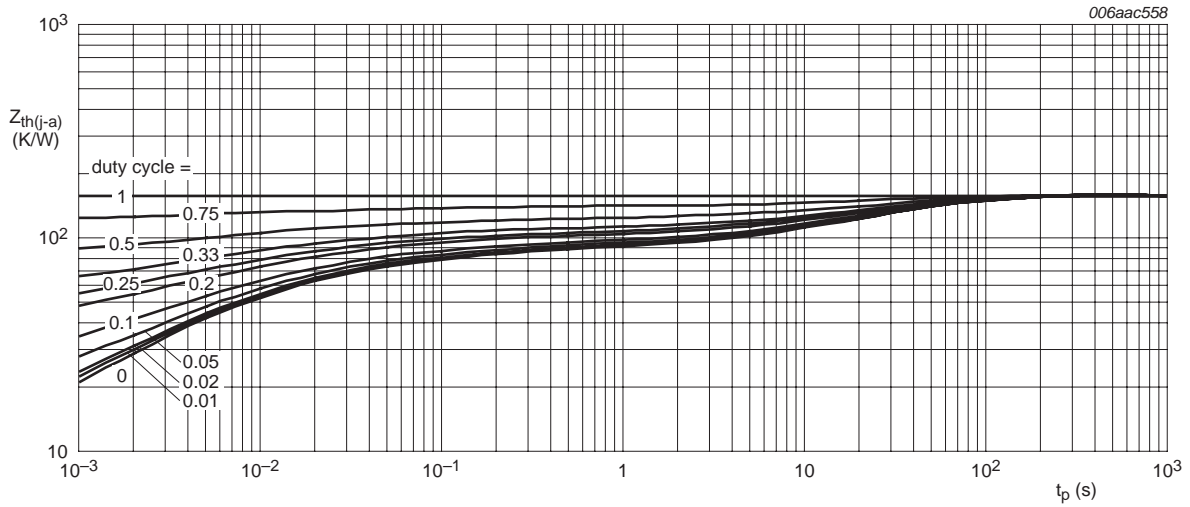

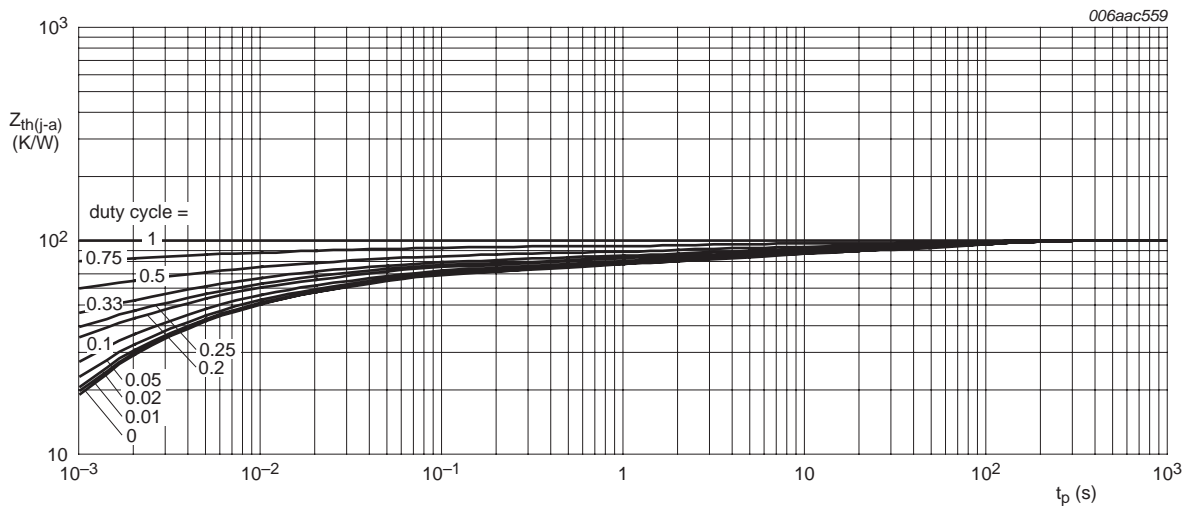

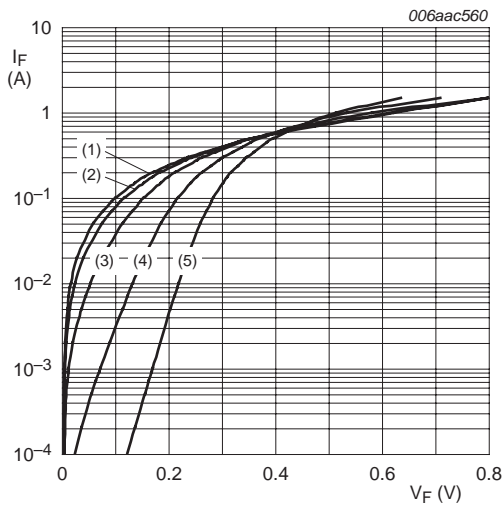

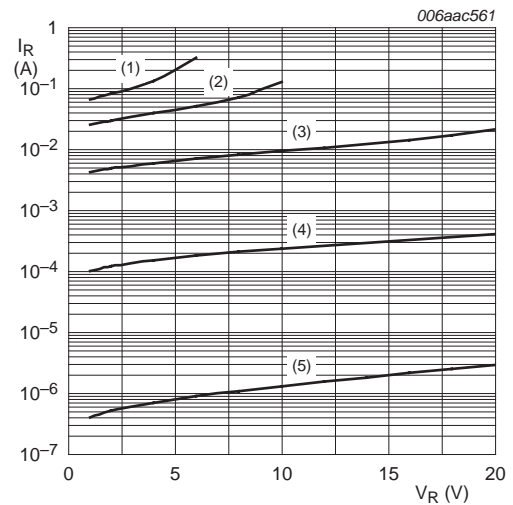

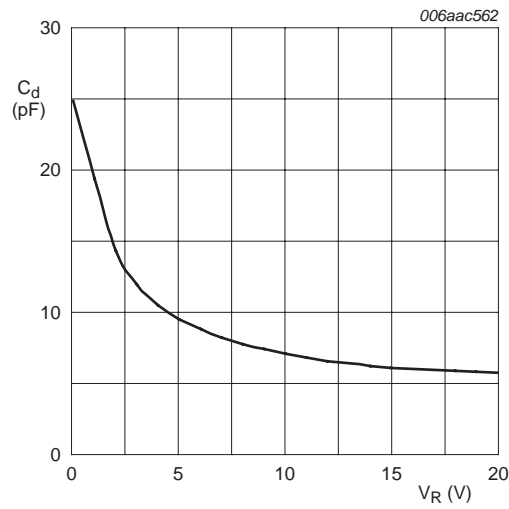

Fig 5. Forward current as a function of forward voltage; typical values



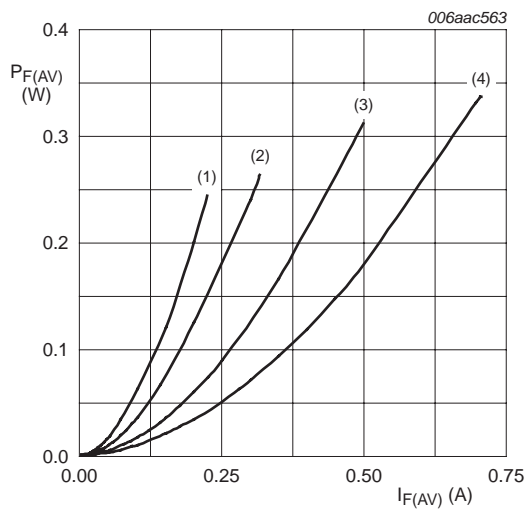

$f = 1 \text{ MHz}; T_{\text{amb}} = 25 \text{ }^\circ\text{C}$

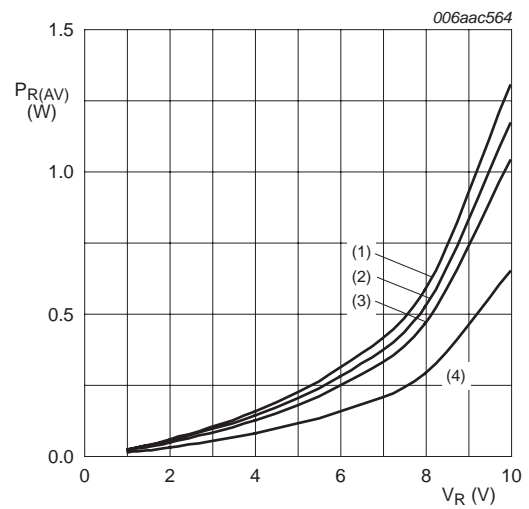
Fig 7. Diode capacitance as a function of reverse voltage; typical values

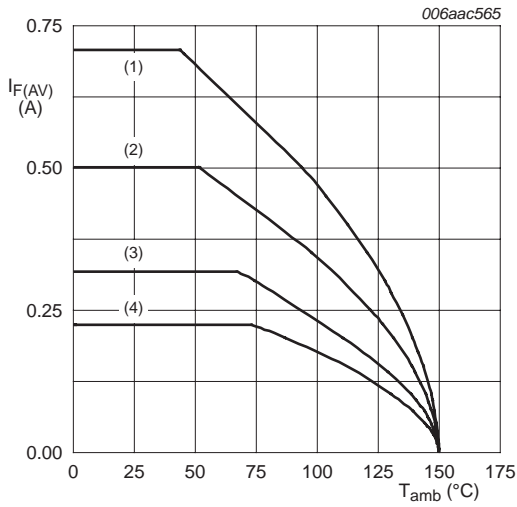
Fig 8. Average forward power dissipation as a function of average forward current; typical values

Fig 9. Average reverse power dissipation as a function of reverse voltage; typical values

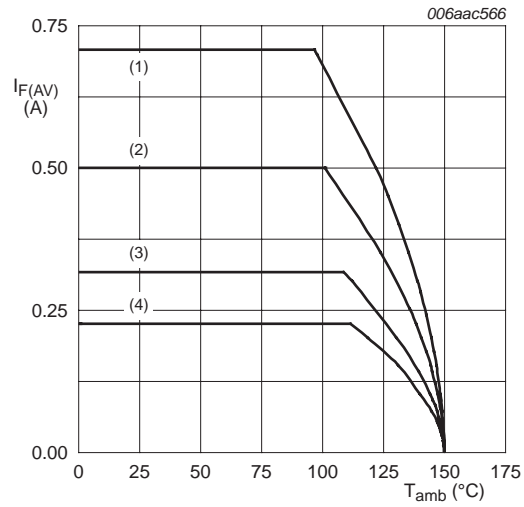

Fig 10. Average forward current as a function of ambient temperature; typical values

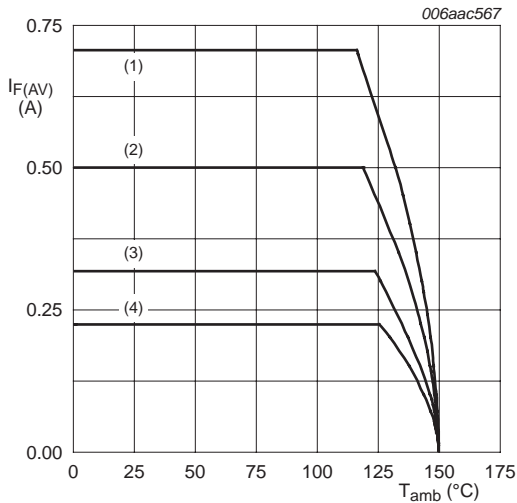

Fig 11. Average forward current as a function of ambient temperature; typical values

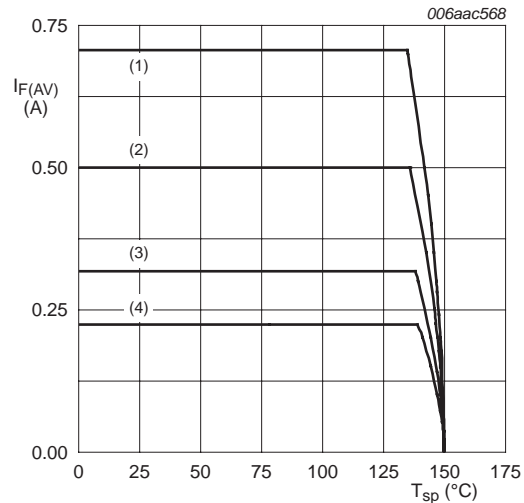


Ceramic PCB, Al_2O_3 , standard footprint

Fig 12. Average forward current as a function of ambient temperature; typical values

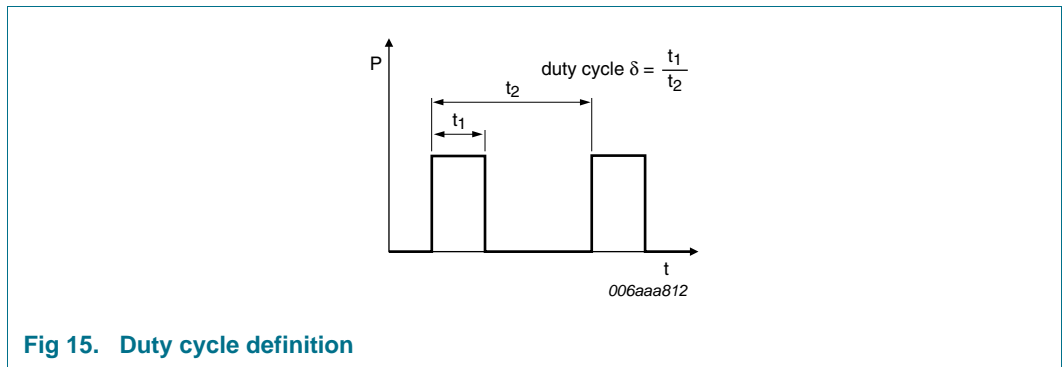
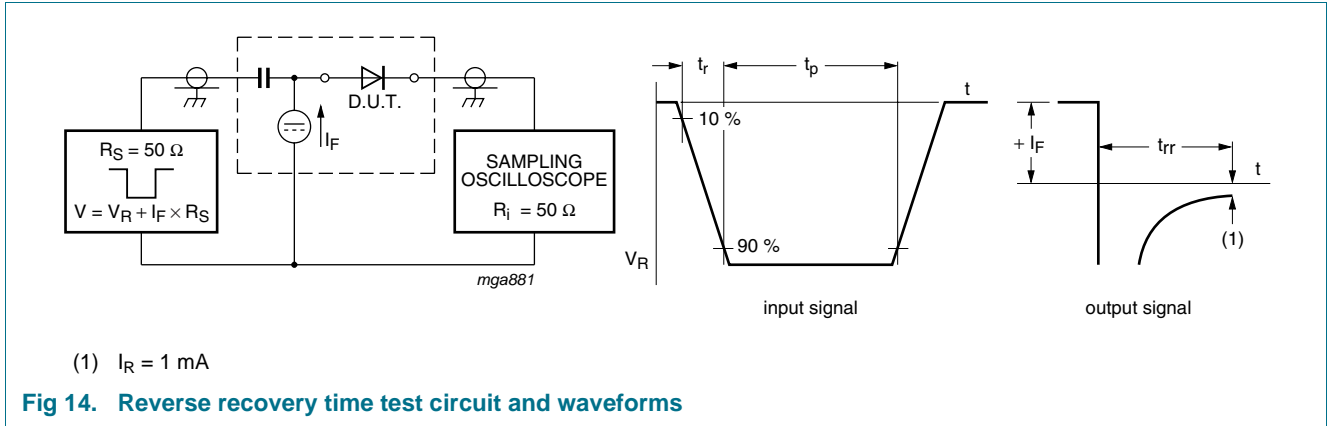
