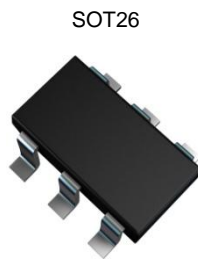

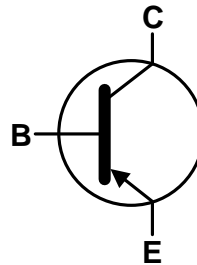

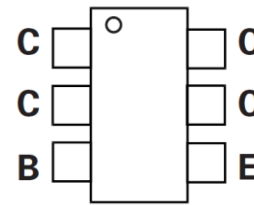

Device Symbol



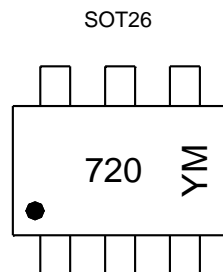

**Package Outline Dimensions**

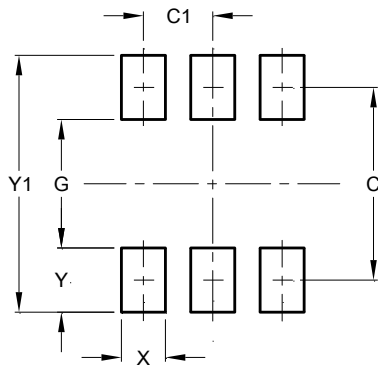
