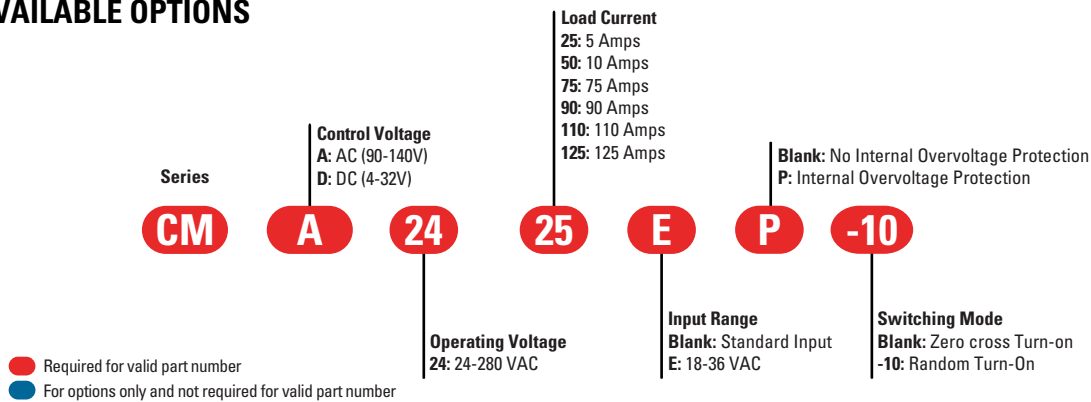

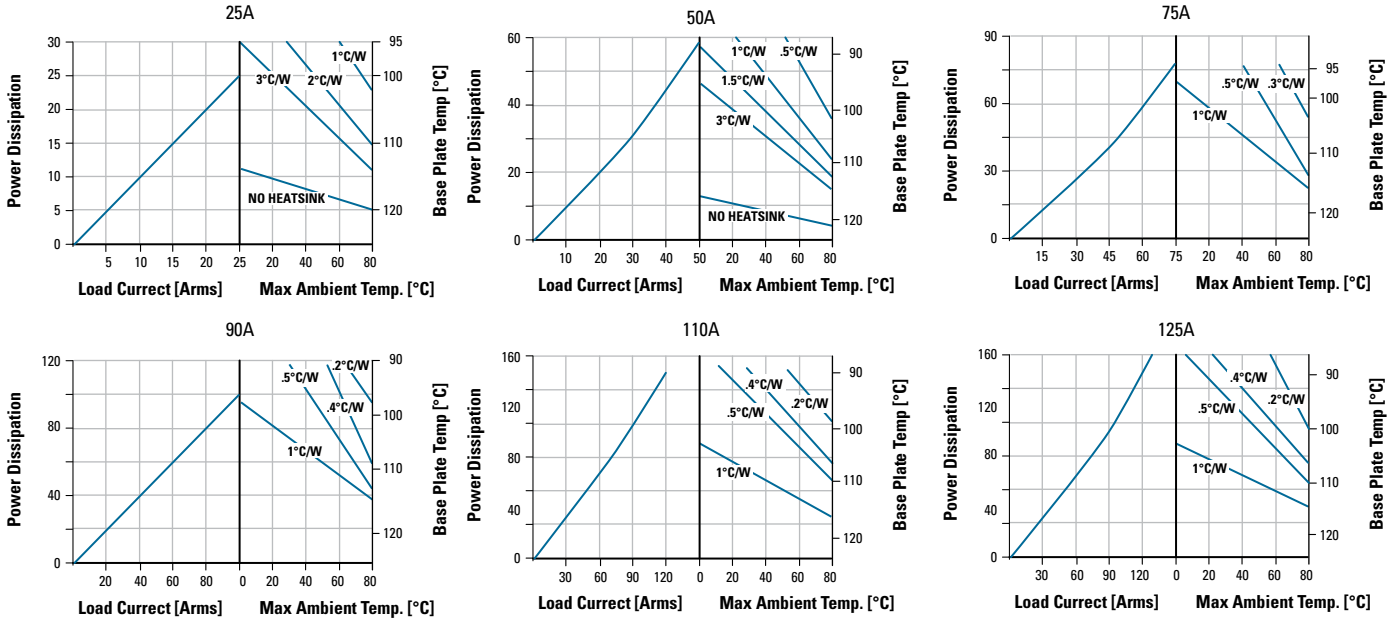

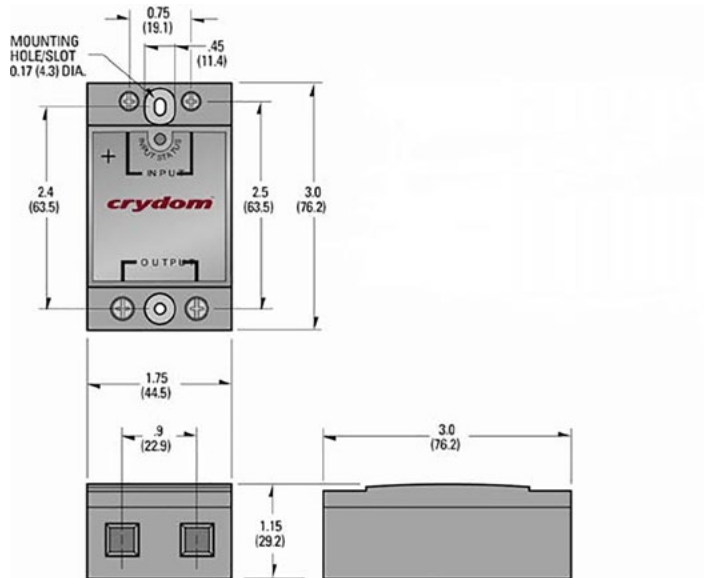
THERMAL DERATE INFORMATION
