Dear Valued Customer:

ITT Cannon GmbH (“ITT”) issued an initial Product Change Notification on October 26, 2023, informing you that ITT is planning to move the production of our stamped contacts for the APD, Trident, Sure Seal, and Micro (MDS) product families. ITT is now issuing this product change notification to specifically inform you that we will be starting this transfer with the move of our **Sure Seal stamped pin contacts** (collectively, “Affected Products”) from our Weinstadt, Germany facility (“Weinstadt Facility”) to our Shenzhen, China facility (“Shenzhen Facility”).

As part of our goal for continuous improvement, we are centralizing the production of our stamped contacts at our Shenzhen Facility, allowing ITT to improve the availability and lead time of the Affected Parts while maintaining a high level of quality.

This facility transfer will change the country of origin (“COO”) for the Affected Products from Germany to China but the **form, fit or function of the Affected Products will not change**. As with any manufacturing location change, we will complete internal quality assurance evaluations. This includes but not limited to testing and inspection.

**We plan on ending production of the Affected Products at our Weinstadt Facility by the end of November 2023.** We expect to have our Shenzhen Facility commence production of the Affected Products in first to second quarters of 2024 and will advise you of the specific date (“Transfer Date”) in a following letter. In the meantime, we will be building up a buffer stock of Affected Products manufactured at our Weinstadt Facility so that we can ensure continued shipments during this transition.

To ensure that this transfer does not cause any disruptions in your supply chain logistics or shipping/receiving, as of the Transfer Date, you will need to make the necessary changes to your internal systems to have your orders for the Affected Products reflect the entity name and address of our Shenzhen Facility (as provided below). We also ask that you work closely with your ITT Customer Service or Sales Representative to review any open orders and future demand for the Affected Products.
