



Fig.1 Grounded emitter propagation characteristics





Fig.2 Grounded emitter output characteristics

Fig.3 DC current gain vs.collector current





Fig.4 Collector-emitter saturation voltage vs. collector current (I)

Fig.5 Collector-emitter saturation voltage vs. collector current (II)




Fig.6 Collector-emitter saturation voltage vs. collector current (III)




Fig.7 Collector-emitter saturation voltage vs. collector current (IV)






Fig.8 Gain bandwidth product vs. emitter current


