




Figure 1. Forward Current Derating Curve




Figure 3. Typical Reverse Characteristics




Figure 5. Maximum Non-Repetitive Surge Current




Figure 2. Typical Instantaneous Forward Characteristics




Figure 4. Typical Junction Capacitance




Figure 6. Typical Forward Characteristics




